AN ACT

1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
2 Statutes, in registration of vehicles, providing for
3 multiple-war veteran plate; and, in fees, further providing
4 for exemption of persons, entities and vehicles from fees.

5 The General Assembly of the Commonwealth of Pennsylvania
6 hereby enacts as follows:

7 Section 1. Title 75 of the Pennsylvania Consolidated
8 Statutes is amended by adding a section to read:

9 § 1369.3. Multiple-war veteran plate.

10 Upon application of any person who is a veteran of all of the
11 following wars: World War II, the Korean War and the Vietnam
12 Conflict, accompanied by a fee of \$20 and by such documentation
13 as the department shall require, the department shall issue to
14 such person a special registration plate designating the vehicle
15 so registered as belonging to a person who is a veteran of all
16 of those three wars. The special registration plate may be used
17 only on one passenger vehicle or one other vehicle with a gross
18 weight of not more than ~~9,000~~ 14,000 pounds.

1 Section 2. Section ~~1901(e)~~ 1901(D) of Title 75 is amended <--  
2 AND SUBSECTION (C) IS AMENDED by adding a paragraph to read: <--  
3 § 1901. Exemption of persons, entities and vehicles from fees.

5 (c) Processing fee in lieu of registration fee.--No  
6 registration fee shall be charged for vehicles registered by any  
7 of the following but the department shall charge a fee of \$10 to  
8 cover the costs of processing for issuing or renewing the  
9 registration:

11 (24) Any veteran who served in all of the following  
12 wars: World War II, the Korean War and the Vietnam Conflict.

13 (D) LIMITATIONS.-- <--

14 (1) VEHICLES TITLED AND REGISTERED UNDER THE PROVISIONS  
15 OF THIS SECTION SHALL BE OPERATED AND USED EXCLUSIVELY FOR  
16 THE PURPOSE FOR WHICH THE VEHICLES WERE ENTITLED TO THE  
17 EXEMPTIONS FROM FEES.

18 (2) ONLY ONE PASSENGER CAR OR TRUCK WITH A REGISTERED  
19 GROSS WEIGHT OF NOT MORE THAN [9,000] 14,000 POUNDS MAY BE  
20 REGISTERED TO ANY PERSON UNDER THE PROVISIONS OF SUBSECTION  
21 (B) (4) AND SUBSECTION (C) (16), (17), (18) [AND], (19) AND  
22 (24).
