Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in assault, providing for the offense 3 of bullying. 4 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 6 Section 1. Title 18 of the Pennsylvania Consolidated 7 Statutes is amended by adding a section to read: § 2709.2. Bullying. 8 (a) Offense defined .-- A person commits the offense of 9 bullying when the person commits a defined crime with the intent 10 11 to: 12 (1) harass, annoy, alarm or intimidate another 13 individual or group of individuals; or (2) place another individual or group of individuals in 14 15 fear of personal injury or property damage. 16 (b) Grading. --17 (1) Except as provided under paragraph (2), an offense

under subsection (a)(1) or (2) committed by a person under 18

- 1 years of age shall constitute a misdemeanor of the third
- 2 <u>degree</u>.
- 3 (2) A third or subsequent offense under subsection
- 4 (a) (1) or (2) committed by a person under 18 years of age
- 5 <u>shall constitute a misdemeanor of the second degree.</u>
- 6 (3) Except as provided under paragraph (4), an offense
- 7 <u>under subsection (a)(1) or (2) committed by a person 18 years</u>
- 8 of age or older shall constitute a misdemeanor of the second
- 9 <u>degree</u>.
- 10 (4) A third or subsequent offense under subsection
- 11 (a) (1) or (2) committed by a person 18 years of age or older
- 12 <u>shall constitute a misdemeanor of the first degree.</u>
- 13 <u>(c) False report.--A person who knowingly gives false</u>
- 14 information to a law enforcement officer with the intent to
- 15 implicate a person under this section commits an offense under
- 16 <u>section 4906</u> (relating to false reports to law enforcement
- 17 authorities).
- 18 <u>(d) Venue.--</u>
- 19 (1) An offense committed under this section may be
- deemed to have been committed at the place where the
- 21 communications or actions were made or received.
- 22 (2) Acts indicating a course of conduct that occur in
- 23 <u>more than one jurisdiction may be used by any other</u>
- jurisdiction in which an act occurred as evidence of a
- 25 <u>continuing pattern of conduct or a course of conduct.</u>
- 26 (e) Application of section. -- This section shall not apply to
- 27 conduct by a party to a labor dispute as defined in the act of
- 28 June 2, 1937 (P.L.1198, No.308), known as the Labor Anti-
- 29 Injunction Act, or to any constitutionally protected activity.
- 30 (f) Definitions.--As used in this section, the following

- 1 words and phrases shall have the meanings given to them in this
- 2 <u>subsection unless the context clearly indicates otherwise:</u>
- 3 "Defined crime." An offense under any of the following:
- 4 (1) Any other provision of this chapter.
- 5 (2) Chapter 33 (relating to arson, criminal mischief and
- 6 <u>other property destruction</u>), <u>exclusive of section 3307</u>
- 7 <u>(relating to institutional vandalism).</u>
- 8 (3) Chapter 35 (relating to burglary and other criminal
- 9 <u>intrusion</u>), exclusive of section 3503 (relating to criminal
- 10 trespass).
- 11 (4) Chapter 41 (relating to forgery and fraudulent
- 12 <u>practices</u>).
- 13 (5) Chapter 57 (relating to wiretapping and electronic
- 14 <u>surveillance</u>).
- 15 (6) Chapter 75 (relating to other offenses).
- 16 (7) Chapter 76 (relating to computer offenses).
- 17 Section 2. This act shall take effect in 60 days.
