AN ACT

- 1 Amending Titles 3 (Agriculture) and 27 (Environmental Resources)
- of the Pennsylvania Consolidated Statutes, in nutrient
- management and odor management, further providing for the
- Nutrient Management Advisory Board; and, in Agricultural
- 5 Advisory Board, further providing for establishment of board, <--
- 6 FOR POWERS OF BOARD AND FOR REVIEW OF REGULATIONS.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 510(a) and (d) of Title 3 of the
- 10 Pennsylvania Consolidated Statutes are amended to read:
- 11 § 510. Nutrient Management Advisory Board.
- 12 (a) Creation. -- There is created the Nutrient Management
- 13 Advisory Board. The board shall consist of 16 members appointed
- 14 by the chairman of the commission and approved by a two-thirds
- 15 vote of the commission. The members so appointed shall consist
- 16 of [five] six active commercial farm owners or operators
- 17 representing the livestock, swine, meat poultry, egg poultry and
- 18 dairy industry nominated by Statewide general farm
- 19 organizations, one veterinary nutrition specialist, one

- 1 representative from the feed industry, one representative from
- 2 the fertilizer industry, [one representative of commercial
- 3 agricultural lenders, one representative of local government,
- 4 one representative of academia who shall be an agronomist or
- 5 plant scientist faculty member of the school of agriculture of a
- 6 Pennsylvania college or university, one representative of
- 7 academia who shall be an animal science faculty member with an
- 8 expertise in odor management from the school of agriculture of a
- 9 college or university within this Commonwealth, one hydrologist,
- 10 two citizen representatives who are not farmers and one
- 11 environmental representative, all of whom shall have sufficient
- 12 knowledge, experience or familiarity with agronomic practices,
- 13 nutrient management practices or odor management practices and
- 14 all of whom shall be residents of this Commonwealth. The six
- 15 <u>active commercial farm owners or operators shall be nominated in</u>
- 16 a manner that provides representation of the northwest, north
- 17 <u>central</u>, <u>northeast</u>, <u>southwest</u>, <u>south central and southeast</u>
- 18 regions of this Commonwealth, corresponding to the regions
- 19 <u>served by the Department of Environmental Protection regional</u>
- 20 offices. Two of the six active commercial farm owners or
- 21 operators shall hold an active concentrated animal feeding
- 22 operation permit as required by the act of June 22, 1937
- 23 (P.L.1987, No.394), known as The Clean Streams Law.
- 24 * * *
- 25 (d) Duties.--The board shall review and comment on all
- 26 commission proposed regulations, the interim guidelines under
- 27 section 504(2) (relating to powers and duties of commission) and
- 28 the interim criteria under section 504(5) developed to implement
- 29 the provisions of this chapter. The commission shall have no
- 30 power to promulgate regulations, interim guidelines or interim

- 1 criteria under this chapter until receipt of written comments on
- 2 the proposed regulations, guidelines or criteria from the board
- 3 or until [60] 90 days have expired from the date when the
- 4 regulations, guidelines or criteria were submitted by the
- 5 commission to the board for its comments. Existing regulations,
- 6 guidelines and criteria shall continue until modified,
- 7 superseded or repealed by the commission.

- 15 (b) Members.--The following persons shall comprise the

- 18 (7) Two members appointed by the secretary that hold an <--
- 19 <u>active concentrated animal feeding operation permit as</u>
- 20 required by the act of June 22, 1937 (P.L.1987, No.394),
- 21 known as The Clean Streams Law.

- 23 (2) A DAIRY PRODUCER, A LIVESTOCK PRODUCER, A POULTRY
- 24 PRODUCER, A GRAIN PRODUCER, A FRUIT PRODUCER, A VEGETABLE
- 25 PRODUCER, A REPRESENTATIVE OF THE ORNAMENTAL HORTICULTURAL
- 26 INDUSTRY, A PRODUCER ENGAGED IN SUSTAINABLE AGRICULTURE, A
- 27 REPRESENTATIVE FROM THE AGRICULTURAL CHEMICAL MANUFACTURERS
- 28 INDUSTRY AND A REPRESENTATIVE FROM THE AGRIBUSINESS INDUSTRY.
- THE GOVERNOR SHALL APPOINT THESE REPRESENTATIVES TO SIT FOR A
- 30 THREE-YEAR TERM. REPRESENTATIVES APPOINTED UNDER THIS

- 1 PARAGRAPH MUST RECEIVE A MAJORITY OF THEIR GROSS INCOME FROM
- 2 THE ACTIVITY WHICH THEY REPRESENT. TWO OF THE REPRESENTATIVES
- 3 APPOINTED UNDER THIS PARAGRAPH SHALL HOLD AN ACTIVE
- 4 CONCENTRATED ANIMAL FEEDING OPERATION PERMIT AS REQUIRED BY
- 5 THE ACT OF JUNE 22, 1937 (P.L.1987, NO.394), KNOWN AS THE
- 6 <u>CLEAN STREAMS LAW.</u>

- 8 § 703. POWERS OF BOARD.
- 9 (A) GENERAL RULE. -- THE BOARD SHALL HAVE THE FOLLOWING
- 10 POWERS:
- 11 (1) PROVIDE ADVICE AND EXPERTISE TO THE SECRETARY
- 12 REGARDING THE NATURE OF AGRICULTURE IN THIS COMMONWEALTH.
- 13 (2) ASSIST THE SECRETARY AND PROVIDE WRITTEN COMMENTS ON
- 14 NEW DEPARTMENTAL POLICY THAT WILL IMPACT UPON AGRICULTURE IN
- 15 THIS COMMONWEALTH.
- 16 (3) ASSIST THE SECRETARY AND PROVIDE COMMENT ON
- 17 REGULATORY, PERMITTING, TECHNICAL GUIDANCE AND POLICY
- 18 PROPOSALS PURSUANT TO SECTION 704 (RELATING TO REVIEW OF
- 19 REGULATIONS).
- 20 (4) PROVIDE COMMENT TO THE SECRETARY REGARDING EXISTING
- 21 DEPARTMENTAL POLICY, PERMITTING, TECHNICAL GUIDANCE AND
- 22 REGULATIONS AFFECTING AGRICULTURE IN THIS COMMONWEALTH.
- 23 (B) EXEMPT REGULATIONS.--REGULATIONS SUBJECT TO REVIEW BY
- 24 THE SEASONAL FARM LABOR COMMITTEE UNDER THE ACT OF JUNE 23, 1978
- 25 (P.L.537, NO.93), KNOWN AS THE SEASONAL FARM LABOR ACT, ARE
- 26 EXEMPT FROM REVIEW UNDER SUBSECTION (A).
- 27 § 704. REVIEW OF REGULATIONS AND OTHER DOCUMENTS.
- 28 (A) NOTICE TO BOARD.--
- 29 (1) THE DEPARTMENT SHALL NOTIFY THE BOARD OF THE
- 30 DEVELOPMENT OF ANY REGULATORY PROPOSAL, PERMIT, TECHNICAL

- 1 GUIDANCE OR DEPARTMENTAL POLICY WHICH WOULD REGULATE OR
- 2 AFFECT AGRICULTURE AS EARLY AS POSSIBLE BUT NOT LESS THAN 120
- 3 DAYS PRIOR TO:
- 4 <u>(I)</u> THE DATE THE ENVIRONMENTAL QUALITY BOARD MEETS
- 5 TO INITIALLY CONSIDER ANY PROPOSED RULEMAKING RESULTING
- from the regulatory proposal[.];
- 7 (II) THE DATE THE DEPARTMENT PUBLISHES NOTICE TO
- 8 <u>ESTABLISH OR CHANGE A PERMIT; OR</u>
- 9 <u>(III) THE DATE THE DEPARTMENT ESTABLISHES A POLICY.</u>
- 10 (2) NOT LESS THAN 60 DAYS PRIOR TO AN ACTION UNDER
- 11 PARAGRAPH (1)(I), (II) OR (III), THE DEPARTMENT SHALL PROVIDE
- 12 THE BOARD WITH A WRITTEN VERSION IN SUBSTANTIALLY THE FORM
- 13 THAT WILL BE PUBLISHED OR ESTABLISHED OF ANY REGULATORY,
- 14 PERMIT, TECHNICAL GUIDANCE OR DEPARTMENTAL POLICY PROPOSAL
- 15 THAT WOULD REGULATE OR AFFECT AGRICULTURE.
- 16 (3) THE DEPARTMENT MAY NOT PUBLISH OR ESTABLISH ANY
- 17 REGULATORY, PERMIT, TECHNICAL GUIDANCE OR DEPARTMENTAL POLICY
- 18 PROPOSAL THAT REGULATES OR AFFECTS AGRICULTURE PRIOR TO BOARD
- 19 REVIEW OF A DOCUMENT PROVIDED UNDER PARAGRAPH (2). ANY
- 20 DISCUSSION OR DECISION BY THE BOARD RELATED TO THE REVIEW
- 21 SHALL BE REFLECTED IN THE MINUTES OF THE BOARD.
- 22 (B) MEETING AND CONSULTATION WITH BOARD. -- AT THE REQUEST OF
- 23 THE BOARD, IF THE REQUEST IS MADE WITHIN 30 DAYS FROM THE DATE
- 24 OF RECEIPT OF THE NOTICE REQUIRED BY SUBSECTION (A), THE
- 25 DEPARTMENT SHALL MEET AND CONSULT WITH THE BOARD IN THE
- 26 FORMULATION OF ANY SUCH REGULATORY, PERMIT, TECHNICAL GUIDANCE
- 27 OR DEPARTMENTAL POLICY PROPOSAL, AND THEREAFTER THE BOARD MAY
- 28 PROVIDE THE DEPARTMENT WITH WRITTEN COMMENTS THEREON.

- 30 Section 3. Members of the Nutrient Management Advisory Board

- 1 AND MEMBERS OF THE AGRICULTURAL ADVISORY BOARD, as of the

- 2 effective date of this section, shall continue to serve as
- 3 members OF THEIR RESPECTIVE BOARDS until their present terms of <--
- 4 office expire.
- 5 Section 4. This act shall take effect in 60 days.
