AN ACT

- 1 Authorizing the Pennsylvania Historical and Museum Commission,
- with the approval of the Governor, to grant and convey
- 3 certain lands and improvements situate in the 47th Ward of
- 4 the City of Philadelphia, Philadelphia County, to New Freedom
- 5 Theatre, Inc.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Conveyance in City of Philadelphia, Philadelphia
- 9 County.
- 10 (a) Authorization. -- The Pennsylvania Historical and Museum
- 11 Commission, with the approval of the Governor, is authorized on
- 12 behalf of the Commonwealth of Pennsylvania to grant and convey
- 13 the following tract of land together with any improvements
- 14 thereon, situate in the 47th Ward of the City of Philadelphia,
- 15 Philadelphia County, to New Freedom Theatre, Inc., for \$1, under
- 16 terms and conditions to be established in an agreement of sale.
- 17 (b) Property description. -- The property to be conveyed under
- 18 subsection (a) consists of the following:
- 19 ALL that certain unit in the property known, named and

- 1 identified in the Declaration referred to below as "Freedom
- 2 Theatre Condominium," located in the 29th Ward of the City and
- 3 County of Philadelphia, Commonwealth of Pennsylvania, which has
- 4 heretofore been submitted to the provisions of the Pennsylvania
- 5 Uniform Condominium Act, 68 Pa.C.S. Section 3101, et seq., by
- 6 the recording in the Philadelphia Department of Records of a
- 7 Declaration dated July 10, 1992, recorded on July 13, 1992 in
- 8 Deed Book VCS 111, Page 353, being and designated in such
- 9 Declaration as Unit 1, as more fully described in said
- 10 Declaration, together with a proportionate undivided interest in
- 11 the Common Elements (as defined in the Declaration) of 30%.
- BEING the same premises conveyed by New Freedom Theatre, Inc.
- 13 to the Pennsylvania Historical and Museum Commission by deed
- 14 dated July 10, 1992, and recorded at the Department of Records
- 15 of the City and County of Philadelphia at Deed Book VCS 123 Page
- 16 132, Document Number 45614463.
- 17 ALSO BEING Philadelphia County OPA Account Number 772726001.
- 18 (c) Conditions. -- The conveyance under this section shall be
- 19 made under and subject to all lawful and enforceable easements,
- 20 servitudes and rights of others, including, but not confined to,
- 21 streets, roadways and rights of any telephone, telegraph, water,
- 22 electric, gas or pipeline companies, as well as under and
- 23 subject to any lawful and enforceable estates or tenancies
- 24 vested in third persons appearing of record, for any portion of
- 25 the land or improvements erected thereon.
- 26 (d) Restriction. -- The conveyance authorized under this
- 27 section shall be made under and subject to the condition, which
- 28 shall be contained in the deed of conveyance, that no portion of
- 29 the property conveyed shall be used as a licensed facility, as
- 30 defined in 4 Pa.C.S. § 1103 (relating to definitions), or any

- 1 other similar type of facility authorized under State law. The
- 2 condition shall be a covenant running with the land and shall be
- 3 binding upon the grantee, its successors and assigns. Should the
- 4 grantee, its successors or assigns permit any portion of the
- 5 property authorized to be conveyed in this section to be used in
- 6 violation of this subsection, the title shall immediately revert
- 7 to and revest in the grantor.
- 8 (e) Deed of conveyance. -- The conveyance shall be made by
- 9 special warranty deed to be executed by the Executive Director
- 10 of the Pennsylvania Historical and Museum Commission in the name
- 11 of the Commonwealth of Pennsylvania.
- 12 (f) Proceeds.--The proceeds from the conveyance under this
- 13 section shall be deposited into the General Fund.
- 14 (g) Alternate disposition. -- In the event that the conveyance
- 15 authorized under this section is not completed within two years
- 16 of the effective date of this subsection, the authority to
- 17 convey the property as specified in subsection (a) shall expire,
- 18 and the property may be disposed of in accordance with section
- 19 2405-A of the act of April 9, 1929 (P.L.177, No.175), known as
- 20 The Administrative Code of 1929.
- 21 Section 2. Effective date.
- This act shall take effect immediately.
