## AN ACT

- Amending Title 24 (Education) of the Pennsylvania Consolidated Statutes, providing for the role of institutions of higher 2 education in immigration enforcement, for restrictions on immigration policies and for duties of the Department of Education. 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: 8 Section 1. Title 24 of the Pennsylvania Consolidated Statutes is amended by adding a chapter to read: 10 CHAPTER 67 11 SANCTUARY CAMPUSES Sec. 12 6701. Definitions. 13 14 6702. Enforcement assistance.
- 15 6703. Prohibition.
- 16 6704. Duty of department.
- 17 § 6701. Definitions.

- 1 The following words and phrases when used in this chapter
- 2 shall have the meanings given to them in this section unless the
- 3 context clearly indicates otherwise:
- 4 "Institution of higher education." Any of the following:
- 5 (1) A community college which is an institution now or
- 6 <u>hereafter created under Article XIX-A of the act of March 10,</u>
- 7 1949 (P.L.30, No.14), known as the Public School Code of
- 8 <u>1949, or the act of August 24, 1963 (P.L.1132, No.484), known</u>
- 9 <u>as the Community College Act of 1963.</u>
- 10 (2) An independent institution of higher education which
- is an institution of higher education located in and
- incorporated or chartered by the Commonwealth, entitled to
- confer degrees as set forth in section 6505 (relating to
- 14 power to confer degrees) and entitled to apply to itself the
- designation "college," "university" or "seminary" as provided
- for by standards and qualifications prescribed by the State
- 17 board under Chapter 65 (relating to private colleges,
- 18 <u>universities and seminaries</u>).
- 19 (3) A State-owned institution.
- 20 (4) A State-related institution.
- 21 § 6702. Enforcement assistance.
- The following may assist in the enforcement of each law,
- 23 mandate, request and order of the Federal Government relating to
- 24 immigration, if the law, mandate, request or order does not
- 25 conflict with the rights guaranteed under the Constitution of
- 26 the United States or the Constitution of Pennsylvania:
- 27 (1) The governing body of an institution of higher
- 28 education.
- 29 <u>(2) An officer or employee of an institution of higher</u>
- 30 education.

- 1 (3) A law enforcement official or a law enforcement
- 2 <u>agency for an institution of higher education.</u>
- 3 § 6703. Prohibition.
- 4 (a) Immigration policy. -- The governing body of an
- 5 <u>institution of higher education may not adopt a rule, order or</u>
- 6 policy which does any of the following:
- 7 (1) Prohibits the enforcement of a Federal law or the
- 8 <u>laws of this Commonwealth pertaining to an immigrant or</u>
- 9 <u>immigration</u>.
- 10 (2) Refuses access by Federal authorities to a campus.
- 11 (3) Directs employees of an institution of higher
- 12 <u>education not to communicate, coordinate or cooperate with</u>
- 13 <u>Federal authorities regarding an individual's immigration</u>
- 14 <u>status.</u>
- 15 (4) Applies an adverse employment action against an
- 16 employee of an institution of higher education for
- 17 communicating, coordinating or cooperating with Federal
- 18 authorities regarding an immigration issue.
- 19 (b) Certification.--Each institution of higher education
- 20 shall annually provide the department with information
- 21 certifying compliance with subsection (a). The information shall
- 22 be provided in a form and manner prescribed by the department.
- 23 (c) Eligibility. -- An institution of higher education shall
- 24 not be eligible for funding through a State appropriation if:
- 25 (1) the institution is in violation of any of the
- 26 provisions under subsection (a) at a campus in this
- 27 Commonwealth; or
- 28 (2) the institution fails to submit the required
- 29 <u>certification</u>.
- 30 (d) Reinstatement. -- The eligibility of an institution of

- 1 higher education to receive State funds may be restored if the
- 2 <u>institution demonstrates compliance with the requirements of</u>
- 3 this section. An institution of higher education determined to
- 4 be in violation of any of the provisions under subsection (a)
- 5 <u>must provide proof satisfactory to the department that it has</u>
- 6 <u>rescinded the prohibited rule, order or policy.</u>
- 7 § 6704. Duty of department.
- 8 The department shall:
- 9 <u>(1) Develop procedures for reporting violations of</u>
- 10 <u>section 6703(a) (relating to prohibition).</u>
- 11 (2) Maintain records of all reports of alleged
- 12 <u>violations and the action taken to resolve the alleged</u>
- 13 <u>violation</u>.
- 14 (3) Report institutions of higher education in violation
- of this chapter to the Secretary of the Budget for the
- 16 <u>purpose of suspending payment of State-appropriated funds.</u>
- 17 Section 2. This act shall take effect in 60 days.
