Amending Title 8 (Boroughs and Incorporated Towns) of the Pennsylvania Consolidated Statutes, in vacancies in office, 2 further providing for filling vacancies in elective borough 3 offices. 4 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: Section 1. Section 901(c), (d) and (e) of Title 8 of the 7 8 Pennsylvania Consolidated Statutes are amended and subsection 9 (a.1) is amended by adding an introductory paragraph to read: § 901. Filling vacancies in elective borough offices. 10 * * * 11 12 (a.1) Vacancy by resignation. -- Except as provided in subsection (e), the following shall apply: 13 * * * 14 15 [Unfilled vacancies. -- If the council of any borough 16 refuses, fails, neglects or is unable, for any reason 17 whatsoever, to fill any vacancy within 30 days after the vacancy happens, as provided in this section, the vacancy shall be 18 19 filled within 15 additional days by the vacancy board.] Vacancy

- 2 (1) A vacancy board shall be convened to fill any
- 3 vacancy within 15 days if the council of any borough, for any
- 4 <u>reason, fails to fill a vacancy after 30 days. Council may</u>
- 5 <u>vote to convene the vacancy board within 30 days of a vacancy</u>
- 6 <u>if it is unable, for any reason, to fill the vacancy and</u>
- 7 provides its justification in a public meeting.
- 8 (2) The vacancy board shall consist of the council,
- 9 exclusive of the mayor, and one registered elector of the
- 10 borough who shall be appointed by the council at the
- 11 council's first meeting each calendar year or as soon as
- 12 practical and who shall act as chair of the vacancy board.
- 13 (3) The vacancy board shall appoint a registered elector
- of the borough, or ward in the case of a ward office, to hold
- the office, if the term continues that long, until the first
- Monday in January after the first municipal election
- occurring more than 60 days after the vacancy occurs, at
- 18 which election an eligible individual shall be elected to the
- office for the remainder of the term.
- 20 (d) [Board] <u>Vacancy board</u> petition. -- [If the vacancy is not
- 21 filled by the vacancy board within 15 days, the] The vacancy
- 22 board chair shall, or, in the case of a vacancy in the chair,
- 23 the remaining members of the vacancy board shall, petition the
- 24 court of common pleas to fill the vacancy by the appointment of
- 25 a registered elector of the borough, or ward in the case of a
- 26 ward, to hold the office, if the term continues that long, until
- 27 the first Monday in January after the first municipal election
- 28 occurring more than 60 days after the vacancy occurs, at which
- 29 election an eliqible individual shall be elected to the office
- 30 for the remainder of the term[.

- 1 (e) Elector petition. -- If vacancies exist in more than a
- 2 majority of the offices of council, the court of common pleas
- 3 shall fill the vacancies upon presentation of petition signed by
- 4 not less than 15 registered electors of the borough.] <u>if either</u>
- 5 of the following occur:
- 6 (1) the vacancy board fails to fill the position within
- 7 15 days; or
- 8 (2) the position of chairperson is vacant and the
- 9 remaining members of the vacancy board provide a
- justification as to why the remaining members cannot fill the
- 11 position sooner than 15 days and vote publicly to disband.
- 12 (e) General vacancy petition. -- Notwithstanding any other
- 13 provision of this section, if vacancies exist in more than a
- 14 majority of the offices of council, the court of common pleas
- 15 shall fill the vacancies upon presentation of petition signed by
- 16 not less than 15 registered electors of the borough or the
- 17 remaining council members. A resignation that precludes a
- 18 majority of council members from acting to accept the
- 19 resignation shall create a vacancy on the date specified in the
- 20 tendered resignation or, if no date is specified, the second
- 21 business day after the day tendered, unless sooner withdrawn in
- 22 writing.
- 23 Section 2. This act shall take effect in 60 days.
