Senator McIlhinney Selected as Game & Fisheries Committee Chairman

I was selected by Senate leadership in January to serve as Chairman of the Senate Game and Fisheries Committee for the 2007-08 session.

The Game and Fisheries Committee works to manage the Commonwealth's wildlife and aquatic resources. For the upcoming session, I plan on pursuing an ambitious agenda that will promote

our sportsmen's activities while preserving the future viability of our natural wildlife habitat and resources.

In addition to this Chairmanship, I was also selected to serve as a member of the following Senate Committees: Law and Justice, Urban Affairs and Housing, State Government, and Transportation. These assignments will allow me to work on



some of the most pressing issues facing Pennsylvanians, and I am pleased to be able to pursue many of my legislative priorities through these committees.

Senator McIlhinney's District Offices Ready to Assist Constituents

To help me meet the needs of all constituents in the 10th Senatorial District, I have two district offices available to serve district residents.

My district offices are located at 22 South Main Street, Suite 220 in Doylestown and 275 Yardley Avenue in Fallsington. Constituents can reach these offices by calling toll-free 1-800-728-8600 (Doylestown) or 1-866-739-8600 (Fallsington).

My district offices provide a wealth of information on many state programs

and issues. Senior citizens can receive help with property tax and rent rebate applications and applications for PACE, Pennsylvania's prescription drug assistance program. There is also information available on other benefits and services available for seniors, such as information on living wills, nursing homes and Medicare supplement plans.

In addition to these senior citizen services, my district offices distribute applications for higher education grants, Adult Basic and CHIP healthcare, copies of maps, absentee ballots, and voter registra-

tion forms. District residents can also pick up copies of state brochures and other public service information.

Constituents can also pick up renewal applications for vehicle and license registrations, state ID cards and other PENNDOT paperwork at these locations.

My district offices also provide information and updates on legislation, as well as copies of state laws and pending legislation. I encourage you to contact me or my district office staff with any questions or concerns about any state agency or program.
