Martin Memorial Highway; designating a bridge, identified as Bridge Key 25507, on that portion of State Route 3006 over the Kinzua Creek in the census-designated place of Westline, Lafayette Township, McKean County, as the Westline Veterans Memorial Bridge; designating a bridge on that portion of State Route 994 over the Blacklog Creek, Cromwell Township, Huntingdon County, as the Lieutenant Joseph O. Stevens Memorial Bridge; designating a portion of State Route 2009, also known as Byberry Road, between State Route 2040, also known as Warminster Road, and State Route 263, also known as Old York Road, in Hatboro Borough, Montgomery County, as the SPC John Kulick Memorial Highway;

4 the Honorable George C. Hasay Memorial Highway; designating a
5 bridge, identified as Bridge Key 5786, carrying State Route
6 3013, known as Dunning's Highway, over South Poplar Run, in
7 Greenfield Township, Blair County, as the Bryan T. "Chipper"
8 Chamberlain Memorial Bridge; designating a bridge, identified
9 as Bridge Key 20703, on State Route 1039, also known as
10 Meredith Street, over Gordan Avenue and Lackawanna Avenue in
11 Carbondale Township, Lackawanna County, as the Joseph
12 Caviston Memorial Bridge; designating a bridge, identified by
13 Bridge Key 19699, on that portion of State Route 2003 over
14 Mahoning Creek in Big Run Borough, Jefferson County, as the
15 SP4 James Wise, Jr., and PFC James Wingert USMC Memorial
16 Bridge; designating a bridge, identified as Bridge Key 36313,
17 carrying Pennsylvania Route 981, also known as Lloyd Avenue,
18 over Loyalhanna Creek in Latrobe, Westmoreland County, as the
19 Trooper Michael Stewart III Memorial Bridge; designating a
20 bridge, identified as Bridge Key 11802, carrying State Route
21 3008 over Clearfield Creek, Beccaria Township, Clearfield
22 County, as the Corporal Cecil J. Snyder Memorial Bridge;
23 designating a bridge, identified as Bridge Key 41673,
24 carrying Oakridge Drive (State Route 3102) over U.S. 219 in
25 Richland Township, Cambria County, as the Cambria County
26 Vietnam Veterans Memorial Bridge; designating the portion of
27 Interstate 76, also known as the Schuylkill Expressway, from
28 Mile Marker 334.5 to Mile Marker 335.5 in Lower Merion
29 Township, Montgomery County, as the Firefighter Thomas Royds
30 Memorial Highway; designating a portion of Pennsylvania Route
31 72 from Segment 0010/Offset 0000 to Segment 0110/Offset 1330
32 in Cornwall Borough, Lebanon County, as the William G.
33 Carpenter Highway; designating a bridge, identified as Bridge
34 Key 46159, carrying Pennsylvania Route 36 on Charger Highway,
35 Blair Township, Blair County, as the Corporal Ralph Hammel
36 Memorial Bridge; designating a bridge, identified as Bridge
37 Key 68510, carrying Pennsylvania Route 271 over Coal Pit Run
38 in Blacklick Township, Cambria County, as The Lazendorfer
39 Brothers Memorial Bridge; designating the portion of State
40 Route 1020, also known as Lawrence Road, between Springhouse
41 Road and Parkway Avenue in Marple Township, Delaware County,
42 as the Richard Paul Memorial Highway; designating a bridge,
43 identified as Bridge Key 68360, carrying State Route 2025,
44 also known as Bristol Road, over U.S. Route 1 in Bensalem
45 Township, Bucks County, as the PFC Robert Joseph Morris
46 Memorial Bridge; designating a bridge, identified as Bridge
47 Key 67570, carrying State Route 2006, also known as New Falls

18 Section 2. Mrs. Madeline Finney Memorial Bridge.

19 (a) Findings.--The General Assembly finds and declares as
20 follows:

21 (1) In 1966, Mrs. Madeline (Madge) Finney decided
22 something must be done about a small bridge, built in 1908 to
23 span Pigeon Creek, in her town of Bentleyville, Pennsylvania,
24 that was simply too small for what was then "modern traffic."

25 (2) Mrs. Finney recognized how unsafe it was for the
26 more than 60 children that crossed the bridge twice daily to
27 go to and from school, including six of her own children.

28 (3) Mrs. Finney spearheaded the four-year campaign to
29 expand the bridge.

30 (4) In a letter to then State Senator William J. Lane,
31 she wrote, "I do not intend to let this Highway Department
32 have any peace until something is done about this bridge."

33 (5) Mrs. Finney also oversaw the letter writing campaign
34 of 95 children and numerous adults to Governor William
35 Scranton.

36 (6) The bridge was completed in 1970.

37 (7) Mrs. Finney died on July 12, 2020.

38 (8) Mrs. Finney's tireless work saved the lives of
39 countless people by fighting for the expansion of this
40 bridge.

41 (b) Designation.--The bridge, identified as Bridge Key
42 35000, on that portion of State Route 2040 in Bentleyville
43 Borough, Washington County, is designated the Mrs. Madeline
44 Finney Memorial Bridge.

45 (c) Signs.--The Department of Transportation shall erect and
46 maintain appropriate signs displaying the name of the bridge to
47 traffic northbound and southbound on the bridge.

48 Section 3. CPT Raymond Harry "Bud" Hetrick Memorial Bridge.

49 (a) Findings.--The General Assembly finds and declares as

1 follows:

2 (1) Raymond Harry Hetrick was born on September 11,
3 1936, in Jefferson County.

4 (2) CPT Hetrick enlisted in the United States Air Force.

5 (3) CPT Hetrick was a pilot and attached to the 1st Air
6 Commando Squadron, Pleiku Airbase, South Vietnam.

7 (4) While serving overseas, CPT Hetrick's primary duty
8 was flying combat missions in a Douglas Skyraider Attack
9 Aircraft (A1-E).

10 (5) CPT Hetrick was killed in action while on a bombing
11 mission about five miles south of Sepone, Savannakhet
12 Province, Laos when his aircraft was struck by hostile fire,
13 crashed and exploded.

14 (6) CPT Hetrick earned several awards for his service,
15 including Air Medal, Purple Heart, United States Aviator
16 Badge Air Force, National Defense Service Medal, Vietnam
17 Campaign Medal, Vietnam Service Medal, Air Force Presidential
18 Unit Citation, Vietnam Gallantry Cross and Air Force Good
19 Conduct Medal.

20 (b) Designation.--The bridge, identified as Bridge Key
21 19557, located on Pennsylvania Route 36 in Brookville Borough,
22 Jefferson County, over the Redbank Creek is designated the CPT
23 Raymond Harry "Bud" Hetrick Memorial Bridge.

24 (c) Signs.--The Department of Transportation shall erect and
25 maintain appropriate signs displaying the name of the bridge to
26 traffic in both directions on the bridge.

27 Section 4. Specialist Five Timothy Rice Memorial Bridge.

28 (a) Findings.--The General Assembly finds and declares as
29 follows:

30 (1) Specialist Five Timothy Rice left high school
31 several months before graduation to enlist in the United
32 States Army during the Vietnam War, later receiving his
33 diploma during a ceremony at his alma mater Marion Center
34 High School.

35 (2) Specialist Five Rice was a heavy equipment operator
36 for the 984 Engine Co. in Vietnam where he was injured.

37 (3) Due to his injuries, Specialist Five Rice earned two
38 Purple Hearts and the Bronze Star and other noble military
39 citations.

40 (4) While serving two tours of duty in Vietnam,
41 Specialist Five Rice contracted Agent Orange causing him
42 years of pain and suffering.

43 (5) Specialist Five Rice returned home after the war and
44 continued to work as a heavy equipment operator.

45 (6) With his wife, Specialist Five Rice owned and
46 operated Rice's Cafe and Store in Purchase Line for more than
47 25 years.

48 (7) Specialist Five Rice passed away on November 24,
49 2020.

50 (b) Designation.--The bridge, identified as Bridge Key
51 19033, located on northbound State Route 119 over State Route

1 286 in White Township, Indiana County, is designated the
2 Specialist Five Timothy Rice Memorial Bridge.

3 (c) Signs.--The Department of Transportation shall erect and
4 maintain appropriate signs displaying the name of the bridge to
5 traffic on the bridge.

6 Section 5. Sergeant Charles R. Learn Memorial Bridge.

7 (a) Findings.--The General Assembly finds and declares as
8 follows:

9 (1) Sergeant Charles R. Learn enlisted in the United
10 States Army on October 24, 1940.

11 (2) Sergeant Learn fought bravely during World War II.

12 (3) During his service he received the Good Conduct
13 Medal, American Defense Service Medal, European-African-
14 Middle Eastern Campaign Medal and three W/3 Bronze Stars.

15 (4) Sergeant Learn returned from service on November 30,
16 1945.

17 (b) Designation.--The bridge, identified as Bridge Key
18 39537, located on that portion of State Route 1005 over a
19 tributary of Crooked Creek, Rayne Township, Indiana County, is
20 designated the Sergeant Charles R. Learn Memorial Bridge.

21 (c) Signs.--The Department of Transportation shall erect and
22 maintain appropriate signs displaying the name of the bridge to
23 traffic in both directions on the bridge.

24 Section 6. Dr. Frank Erdman Boston Memorial Highway.

25 (a) Findings.--The General Assembly finds as follows:

26 (1) Frank Erdman Boston was born March 10, 1891, in
27 Philadelphia and later attended Lincoln University,
28 originally established as The Ashmun Institute, the nation's
29 first degree-granting Historically Black College and
30 University.

31 (2) Frank Boston then attended the Medico-Chirurgical
32 College, an outgrowth of the Medico-Chirurgical Society of
33 Philadelphia, which merged with the University of
34 Pennsylvania Medical College and Jefferson Medical College.

35 (3) Dr. Boston enlisted and was immediately given the
36 rank of first lieutenant in the Army Medical Reserve Corps,
37 where he served in France during World War I with the rank of
38 captain and ended his military service as a major.

39 (4) After the war, Dr. Boston returned to work in
40 Philadelphia and later settled in Lansdale where he opened
41 the Elm Terrace Hospital, which was later renamed North Penn
42 Hospital and subsequently became part of the Abington-
43 Jefferson Health Systems.

44 (5) Dr. Boston also formed a First Aid Emergency Squad
45 in Lansdale, eventually known as the Volunteer Medical
46 Service Corps of Lansdale, and was a member of the Reserve
47 Officers Association of Military Surgeons, the Montgomery
48 County Medical Society and the American Medical Association.

49 (6) Dr. Boston died February 8, 1960, at 69 years of
50 age, and was buried in Lansdale.

51 (b) Designation.--The portion of State Route 2004, also

known as North Broad Street, within the Borough of Lansdale and Hatfield Township, Montgomery County, is designated the Dr. Frank Erdman Boston Memorial Highway.

(c) Signs.--The Department of Transportation shall erect and maintain appropriate signs displaying the name of the highway to traffic in both directions on the highway.

Section 7. The PVT William L. Hadden Memorial Bridge.

(a) Findings.--The General Assembly finds and declares as follows:

(1) PVT William L. Hadden, a native of East Run, gave his life in service to his country during World War II.

(2) PVT Hadden entered the Army on September 14, 1943, and completed basic training at Ft. McClellan, Alabama.

(3) On July 11, 1944, PVT Hadden was killed in action in Saipan at only 19 years of age.

(4) PVT Hadden was one of five brothers who served with honor in the United States military.

(b) Designation.--The bridge, identified as Bridge Key 57053, located over Dixon Run at the intersection of State Route 1012 to Pennsylvania Route 403 in Green Township, Indiana County, is designated the PVT William L. Hadden Memorial Bridge.

(c) Signs.--The Department of Transportation shall erect and maintain appropriate signs displaying the name of the bridge to traffic in both directions on the bridge.

Section 8. Sergeant Richard Ivory Cullen Memorial Bridge.

(a) Findings.--The General Assembly finds and declares as follows:

(1) Sergeant Richard Ivory Cullen was born on August 25, 1947, in Greensburg, Pennsylvania.

(2) In 1967, Sergeant Cullen was drafted in the United States Army and served during the Vietnam War.

(3) Sergeant Cullen was assigned to the American Division, 1st Squadron, 1st Calvary Regiment, B Troop.

(4) Sergeant Cullen was killed in action on May 23, 1968, while dutifully serving his country in South Vietnam, Quang Tin province.

(5) Sergeant Cullen was awarded the Purple Heart.

(b) Designation.--The bridge, identified as Bridge Key 36020, located on that portion on Pennsylvania Route 66, known as Main Street, over the Norfolk Southern Railway, City of Greensburg, Westmoreland County, is designated the Sergeant Richard Ivory Cullen Memorial Bridge.

(c) Signs.--The Department of Transportation shall erect and maintain appropriate signs displaying the name of the bridge to traffic in both directions on the bridge.

Section 9. Carl E. Keith Memorial Bridge.

(a) Findings.--The General Assembly finds and declares as follows:

(1) Carl E. Keith was drafted into the United States Army in 1943.

(2) Carl E. Keith was killed in action in 1944 in Burma

1 during World War II.

2 (b) Designation.--The bridge, identified as Bridge Key
3 19231, located on State Route 1014 in Green Township, Indiana
4 County, over the abandoned Conrail Railroad is designated the
5 Carl E. Keith Memorial Bridge.

6 (c) Signs.--The Department of Transportation shall erect and
7 maintain appropriate signs displaying the name of the bridge to
8 traffic in both directions on the bridge.

9 Section 10. Kunkle Firefighter Edward L. Nulton, Sr., Memorial
10 Highway.

11 (a) Findings.--The General Assembly finds that:

12 (1) Edward L. Nulton, Sr., was born July 30, 1956, and
13 was a resident of Beaumont, Monroe Township, Wyoming County.

14 (2) Mr. Nulton was a volunteer firefighter with the
15 Kunkle Volunteer Fire Company in Dallas Township, Luzerne
16 County, for 10 years.

17 (3) On September 21, 2018, Mr. Nulton was struck by a
18 dump truck while directing traffic at the scene of a
19 vehicular accident and sustained injuries.

20 (4) As a result of his injuries, Mr. Nulton died on
21 September 19, 2019.

22 (b) Designation.--The portion of Pennsylvania Route 309 from
23 the intersection with Pennsylvania Route 29 in Monroe Township,
24 Wyoming County, to the intersection with State Route 1026 in
25 Dallas Township, Luzerne County, is designated the Kunkle
26 Firefighter Edward L. Nulton, Sr., Memorial Highway.

27 (c) Signs.--The Department of Transportation shall erect and
28 maintain appropriate signs displaying the name of the highway to
29 traffic in both directions on the highway.

30 Section 11. Sergeant First Class Randy McCaulley Memorial
31 Bridge.

32 (a) Findings.--The General Assembly finds and declares as
33 follows:

34 (1) Sergeant First Class Randy McCaulley enlisted in the
35 Army after graduating from Marion Center High School in 1979
36 and served for four years.

37 (2) In 1984, SFC McCaulley joined the Pennsylvania
38 National Guard and was assigned to Company A, 1st Battalion,
39 110th Infantry based in Indiana, Pennsylvania.

40 (3) Company A, which included SFC McCaulley, was
41 mobilized in January 2005 and arrived for service in June
42 2005 with the 2nd Brigade Combat Team in Ramadi, about 65
43 miles west of Baghdad.

44 (4) On March 23, 2006, SFC McCaulley was shot and killed
45 by small arms fire while on a combat patrol with his unit in
46 Mudiq, Iraq.

47 (5) The Pennsylvania National Guard posthumously
48 promoted SFC McCaulley from staff sergeant to sergeant first
49 class and he was awarded the Purple Heart.

50 (b) Designation.--The bridge, identified as Bridge Key
51 41272, located on Pennsylvania Route 286 over Crooked Creek in

1 Rayne Township, Indiana County, is designated the Sergeant First
2 Class Randy McCaulley Memorial Bridge.

3 (c) Signs.--The Department of Transportation shall erect and
4 maintain appropriate signs displaying the name of the bridge to
5 traffic in both directions on the bridge.

6 Section 12. Gerald "Jerry" Confer Memorial Bridge.

7 (a) Findings.--The General Assembly finds and declares as
8 follows:

9 (1) Gerald Confer was born August 21, 1952, in
10 Clearfield.

11 (2) Mr. Confer attended Clearfield High School.

12 (3) Mr. Confer was employed by the Department of
13 Transportation and worked for the Systematic Technique to
14 Analyze and Manage Pennsylvania's Pavements Program.

15 (4) On September 18, 1984, Mr. Confer, along with his
16 coworker, James Bennett, sustained critical injuries when
17 their PennDOT vehicle was struck in the rear by a truck at
18 Exit 16 on Interstate 80 resulting in Mr. Confer's death on
19 September 19, 1984.

20 (5) The Department of Transportation established the
21 Memorial Bridge Project to name a bridge after a fallen
22 worker as an acknowledgment of their service and dedication
23 to this Commonwealth. The bridge dedications will provide a
24 visual reminder to motorists to slow down in work zones.

25 (b) Designation.--The bridge, identified as Bridge Key
26 45531, carrying Pennsylvania Route 879 over the West Branch
27 Susquehanna River, Lawrence Township, Clearfield County, is
28 designated the Gerald "Jerry" Confer Memorial Bridge.

29 (c) Signs.--The Department of Transportation shall erect and
30 maintain appropriate signs displaying the name of the bridge to
31 traffic in both directions on the bridge.

32 Section 13. Trooper John W. Marin Memorial Bridge.

33 (a) Findings.--The General Assembly finds and declares as
34 follows:

35 (1) Trooper John W. Marin was born May 20, 1945, in
36 Geneva to the late Lida Martin Marin and the late John Marin,
37 Sr.

38 (2) Upon graduation in 1963 from Conneaut Lake High
39 School in Crawford County, Trooper Marin worked at the
40 Meadville Malleable Iron Company.

41 (3) On November 7, 1968, Trooper Marin dedicated his
42 life to public safety by joining the Pennsylvania State
43 Police.

44 (4) During his career with the Pennsylvania State
45 Police, Trooper Marin served as a sniper, patrol trooper,
46 public information officer, liaison to the United States
47 Marshals Service and criminal investigator.

48 (5) Trooper Marin was awarded the Letter of Commendation
49 by the Commonwealth of Pennsylvania as lead investigator on a
50 three-year, multistate investigation in the 1980s.

51 (6) According to William V. Conley, a former Federal,

1 State and county prosecutor and First Deputy Attorney
2 General, the investigation in which Trooper Marin was awarded
3 the Letter of Commendation was one of the largest known
4 tractor trailer theft rings in the eastern United States and
5 involved multiple arsons, corrupt state officials, a murder
6 conspiracy, a conspiracy to steal M-16 ammunition from an
7 armory in Indiana and the prosecution of a corrupt sheriff in
8 Georgia by the Federal Bureau of Investigation and culminated
9 in a Racketeer Influenced and Corrupt Organizations
10 prosecution and conviction of the leader of this wide-ranging
11 organization in Pittsburgh.

12 (7) Trooper Marin retired from the Pennsylvania State
13 Police in 1994.

14 (8) Trooper Marin studied martial arts, earning his
15 Black Belt in Kung Fu and Red Sash in Kuntao in 1975.

16 (9) Trooper Marin was respected in Crawford County for
17 his dedication and affinity for his community from life
18 through death with his request that his ashes find their
19 final resting place at Bridge Key 13321, located on State
20 Route 3021, also known as Geneva Road, over the Conneaut
21 Outlet, Union Township, Crawford County.

22 (10) Union Township and Greenwood Township, Crawford
23 County, as well as the Pennsylvania State Police, support the
24 designation of Bridge Key 13321, located on State Route 3021,
25 also known as Geneva Road, over the Conneaut Outlet, Union
26 Township, Crawford County, as the Trooper John W. Marin
27 Memorial Bridge.

28 (11) Trooper Marin passed away peacefully with his
29 family at his side on November 3, 2018.

30 (b) Designation.--The bridge, identified as Bridge Key
31 13321, located on State Route 3021, also known as Geneva Road,
32 over the Conneaut Outlet, Union Township, Crawford County, is
33 designated the Trooper John W. Marin Memorial Bridge.

34 (c) Signs.--The Department of Transportation shall erect and
35 maintain appropriate signs displaying the name of the bridge to
36 traffic in both directions on the bridge.
37 Section 14. Michael Dillman Memorial Bridge.

38 (a) Findings and declarations.--The General Assembly finds
39 and declares as follows:

40 (1) Michael Dillman, who worked for the Department of
41 Transportation as an equipment operator, suddenly lost his
42 life in a vehicle rollover accident on August 15, 2011.

43 (2) Mr. Dillman was the husband of Kimberly for 27 years
44 and father to Amanda and Alicia.

45 (3) It is most befitting that the memory of Mr. Dillman
46 be honored in a manner that captures his hard work in the
47 construction and maintenance of our State roadways, highways
48 and bridges and his dedication to the mission of the
49 Department of Transportation.

50 (b) Designation.--The bridge, identified as Bridge Key
51 43235, located on State Route 2012, also known as the Fish and

1 Game Road, in Mount Joy and Germany Townships, Adams County,
2 over Alloway Creek, is designated the Michael Dillman Memorial
3 Bridge.

4 (c) Signs.--The Department of Transportation shall erect and
5 maintain appropriate signs displaying the name of the bridge to
6 traffic in both directions on the bridge.

7 Section 15. PFC Donald E. Hunter, USMC Memorial Bridge.

8 (a) Findings.--The General Assembly finds and declares as
9 follows:

10 (1) Private First Class Donald E. Hunter was born on
11 June 27, 1948, in South Fork.

12 (2) PFC Hunter graduated basic training on August 11,
13 1967, and entered the United States Marine Corps.

14 (3) PFC Hunter served in the Vietnam War and, at the age
15 of 19, was killed in action on May 1, 1968, in the Quang Tri
16 Province while assisting a wounded Marine.

17 (b) Designation.--The bridge, identified as Bridge Key 8639,
18 carrying State Route 3024, also known as Ragers Hill Road, over
19 State Route 2006, Norfolk Southern Railroad, and the South Fork
20 Branch Little Conemaugh River in Croyle Township, Cambria
21 County, is designated the PFC Donald E. Hunter, USMC Memorial
22 Bridge.

23 (c) Signs.--The Department of Transportation shall erect and
24 maintain appropriate signs displaying the name of the bridge to
25 traffic in both directions on the bridge.

26 Section 16. John "Sonny" Kuhar, Jr., Memorial Bridge.

27 (a) Findings.--The General Assembly finds and declares as
28 follows:

29 (1) John Kuhar, Jr., was born on May 29, 1941, in
30 Johnstown, Pennsylvania.

31 (2) Mr. Kuhar graduated from Nanty Glo-Vintondale Joint
32 High School in 1959.

33 (3) In 1960, Mr. Kuhar began to work in law enforcement
34 while working at Nevy Brothers Store in Vintondale.

35 (4) Mr. Kuhar served as a police officer in Vintondale
36 Borough from 1960 to 1976, Nanty Glo Borough from 1976 to
37 1988 and Blacklick Township from 1980 until his retirement in
38 2013.

39 (5) Mr. Kuhar served as Chief of Police in both
40 Vintondale Borough and Blacklick Township.

41 (6) In 1987, Mr. Kuhar joined the Cambria County
42 Sheriff's Office and served honorably until his death in
43 2020.

44 (7) During his dedicated 60-year law enforcement tenure,
45 Mr. Kuhar received numerous awards.

46 (8) Mr. Kuhar also received a Valor Award from the
47 Volunteer Firemen's Association of Cambria County and
48 Vicinity and the Police Officer of the Year Award from the
49 Nanty Glo Borough Police Department.

50 (9) Mr. Kuhar's Cambria County Deputy Sheriff's badge
51 number 13 is now retired.

1 (10) Mr. Kuhar was a lifelong resident of Vintondale
2 Borough, serving as mayor and constable, while also being a
3 lifetime member of the Vintondale Volunteer Fire Department.

4 (b) Designation.--The bridge, identified as Bridge Key 8672,
5 located on State Route 3045 in Vintondale Borough, Cambria
6 County, over the South Branch Blacklick Creek is designated the
7 John "Sonny" Kuhar, Jr., Memorial Bridge.

8 (c) Signs.--The Department of Transportation shall erect and
9 maintain appropriate signs displaying the name of the bridge to
10 traffic in both directions on the bridge.

11 Section 17. Ross W. Dixon Memorial Bridge.

12 (a) Findings.--The General Assembly finds and declares as
13 follows:

14 (1) Mr. Ross W. Dixon was born on October 19, 1952, in
15 Spangler, Pennsylvania.

16 (2) Mr. Dixon followed in his father's footsteps,
17 serving as a part-time police officer with the Ebensburg
18 Borough Police Department.

19 (3) Mr. Dixon began his career with the Cambria County
20 Sheriff's Office in 2005, working several positions
21 throughout the Cambria County Courthouse.

22 (4) Throughout Mr. Dixon's nearly 50-year career in law
23 enforcement, he served as his father did with unconditional
24 kindness.

25 (5) Mr. Dixon was very active, well known and loved
26 throughout the Ebensburg community.

27 (6) Mr. Dixon taught karate, as well as coached baseball
28 and track.

29 (7) Mr. Dixon passed away from an on-duty exposure of
30 COVID-19 on February 9, 2021.

31 (8) At the time of his death, Deputy Ross Dixon was
32 employed full-time with the Cambria County Sheriff's Office.

33 (9) Mr. Ross W. Dixon's name will be formally dedicated
34 on the National Law Enforcement Officer's Memorial Wall in
35 Washington, DC in May of 2022.

36 (b) Designation.--The bridge, identified as Bridge Key
37 45635, located on State Route 1036 in Ebensburg Borough, Cambria
38 County, over Howells Run at Lake Rowena is designated the Ross
39 W. Dixon Memorial Bridge.

40 (c) Signs.--The Department of Transportation shall erect and
41 maintain appropriate signs displaying the name of the bridge to
42 traffic in both directions on the bridge.

43 Section 18. Sheriff Bob Kolar, Sr., Memorial Bridge.

44 (a) Findings.--The General Assembly finds and declares as
45 follows:

46 (1) Robert "Bob" Alan Kolar, Sr., was born on February
47 14, 1945, in Ebensburg, Pennsylvania.

48 (2) Sheriff Kolar was a graduate of Bishop Carroll High
49 School located in Ebensburg.

50 (3) Sheriff Kolar went on to attend Mount Aloysius
51 College and Indiana University of Pennsylvania graduating

1 with a degree in criminology.

2 (4) Following graduation, Sheriff Kolar joined the
3 Marine Corps and served honorably for two years.

4 (5) When his military service came to an end, Sheriff
5 Kolar began his law enforcement career joining the
6 Pennsylvania State Police in 1968.

7 (6) Sheriff Kolar served as a Pennsylvania State Trooper
8 for 25 years.

9 (7) In his 25 years of service, Sheriff Kolar was
10 assigned to various Troops across this Commonwealth, but he
11 mainly served in Troop A based in Ebensburg and retired in
12 1992.

13 (8) Sheriff Kolar was first elected as Cambria County
14 sheriff in 1998.

15 (9) During his tenure, Sheriff Kolar served as a board
16 member of the National Sheriff's Association Domestic
17 Violence Committee, as the president of the Cambria County
18 Prison Board for 15 years and he was the first Sheriff
19 appointed to the Pennsylvania Commission on Crime and
20 Delinquency by the Governor in 2008.

21 (10) In 2016, Sheriff Kolar entered into a partnership
22 with the U.S. Marshals Fugitive Task Force and in 2017 he
23 received recognition for removing 150 criminals off the
24 street in the first year.

25 (11) During his time in office, Sheriff Bob Kolar was
26 chosen to provide security for United States Presidents
27 George W. Bush, Bill Clinton and Donald Trump when the
28 Presidents visited Cambria County.

29 (12) Sheriff Kolar served as the manager for Ebensburg
30 Little League Baseball for nine years.

31 (13) Mr. Kolar was a member of many clubs and
32 organizations and served on many committees such as the
33 Chiefs of Police Association, Fraternal Order of Police, the
34 Pennsylvania Sheriffs' Association, the National Sheriffs'
35 Association, the VFW, Marine Corps League, Vietnam Veterans
36 of America, the Moose, the Elks, the Eagles, the American
37 Legion and the National Rifle Association.

38 (14) Sheriff Kolar passed away on May 6, 2020, while
39 still serving the people of Cambria County as sheriff.

40 (15) Sheriff Kolar left behind a legacy of service and
41 commitment to the community that will be remembered for years
42 to come.

43 (16) Sheriff Kolar had the longest tenure as sheriff in
44 Cambria County history.

45 (b) Designation.--The bridge, identified as Bridge Key 8604,
46 located on State Route 2014, over U.S. 22, Cambria County, is
47 designated the Sheriff Bob Kolar, Sr., Memorial Bridge.

48 (c) Signs.--The Department of Transportation shall erect and
49 maintain appropriate signs displaying the name of the bridge to
50 traffic in both directions on the bridge and under the bridge
51 along U.S. 22.

1 Section 19. Commissioner William E. Ames Memorial Highway.

2 (a) Findings.--The General Assembly finds and declares as
3 follows:

4 (1) William E. Ames was a lifelong educator as a teacher
5 in the Derry Township School District before retiring after
6 30 years of service in the profession.

7 (2) Commissioner Ames was a dedicated public servant,
8 first elected as a South Londonderry Township supervisor and
9 then as a Lebanon County commissioner for the past 10 years.

10 (3) Commissioner Ames supported countless charitable
11 organizations in the Lebanon Valley and devoted time to
12 numerous volunteer groups and activities.

13 (4) In addition to his teaching career and years in
14 public office, Commissioner Ames was a successful business
15 owner in the Lebanon Valley.

16 (5) Commissioner Ames was deeply devoted to making
17 Lebanon County a better place for everyone who lived there.

18 (b) Designation.--The section of Pennsylvania Route 322 from
19 the intersection with County Line Lane to the intersection with
20 Pennsylvania Route 117 through Campbelltown in South Londonderry
21 Township, Lebanon County, is designated the Commissioner William
22 E. Ames Memorial Highway.

23 (c) Signs.--The Department of Transportation shall erect and
24 maintain appropriate signs displaying the name of the highway to
25 traffic in both directions on the highway.

26 Section 20. Chief Vernon Moses Memorial Highway.

27 (a) Findings.--The General Assembly finds that:

28 (1) The 100th anniversary of the establishment of the
29 Ross Township Police Department, in Allegheny County, occurs
30 in 2022 and Ross Township wishes to memorialize the sacrifice
31 and service of the department's former chief of police,
32 Vernon Moses.

33 (2) Chief Vernon Moses served as a police officer for 12
34 years and was the first police chief of the Ross Township
35 Police Department.

36 (3) On May 3, 1932, Chief Moses lost his life in the
37 line of duty from gun violence that was pervasive in the
38 community during the Prohibition Era.

39 (4) Chief Moses is the only Ross Township police officer
40 to have been killed in the line of duty during the
41 department's 100-year history.

42 (5) The story of Chief Moses's death has been passed
43 down through the generations, including by his surviving
44 grandson, and will continue to shape the course of the Ross
45 Township Police Department into the future.

46 (6) The community wishes to honor Chief Moses's legacy
47 by designating in his name the area where he gave the
48 ultimate sacrifice and to recognize his life and service
49 protecting Ross Township.

50 (b) Designation.--The portion of U.S. Route 19 between Ivory
51 Avenue and Cemetery Lane in Ross Township, Allegheny County, is

1 designated the Chief Vernon Moses Memorial Highway.

2 (c) Signs.--The Department of Transportation shall erect and
3 maintain appropriate signs displaying the name of the highway to
4 traffic in both directions on the highway.

5 Section 21. Francis and Robert Zerbee Memorial Bridge.

6 (a) Findings.--The General Assembly finds and declares as
7 follows:

8 (1) Mr. Francis Zerbee was born September 21, 1923, in
9 Cambria County.

10 (2) Private First Class Francis Zerbee served in the
11 United States Army.

12 (3) During World War II, Private First Class Francis
13 Zerbee served in the 318th Infantry Regiment, 80th Infantry
14 Division in Saint Lo, France.

15 (4) Private First Class Francis Zerbee was fatally
16 wounded on November 26, 1944.

17 (5) Private First Class Francis Zerbee received a Purple
18 Heart for his service to the nation.

19 (6) Mr. Robert Zerbee was born November 11, 1918, in
20 Chest Springs, Cambria County.

21 (7) Corporal Robert Zerbee served in the United States
22 Army.

23 (8) During World War II, Corporal Robert Zerbee served
24 in the Tank Battalion in Anzio Beachhead, Italy.

25 (9) Corporal Robert Zerbee was fatally wounded on May
26 24, 1944.

27 (10) Private First Class Francis Zerbee and Corporal
28 Robert Zerbee were the sons of Mr. and Mrs. John Zerbee of
29 Patton.

30 (b) Designation.--The bridge identified as Bridge Key 8360,
31 located on Pennsylvania Route 36 over Clearfield Creek, Ashville
32 Borough, Cambria County, is designated the Francis and Robert
33 Zerbee Memorial Bridge.

34 (c) Signs.--The Department of Transportation shall erect and
35 maintain appropriate signs displaying the name of the bridge to
36 traffic in both directions on the bridge.

37 Section 22. Army Sergeant Joshua James Rimer Memorial Road.

38 (a) Findings.--The General Assembly finds and declares as
39 follows:

40 (1) Army Sergeant Joshua James Rimer was born on April
41 18, 1985, and gave his life in the line of duty on July 22,
42 2009, while on a mission with the United States Army in
43 Afghanistan.

44 (2) Sergeant Rimer was raised in New Sewickley Township,
45 Beaver County.

46 (3) After graduating from Freedom Area High School in
47 2003, Sergeant Rimer enlisted in the United States Army.

48 (4) Sergeant Rimer's experience in the United States
49 Army spanned the globe, from the United States to Germany,
50 Iraq and Afghanistan through multiple deployments.

51 (5) During his service, Sergeant Rimer was awarded a

1 Bronze Star and two Purple Hearts, among other commendations.

2 (6) Throughout his career, Sergeant Rimer steadfastly
3 displayed exceeding loyalty and dedication to the United
4 States of America as well as the United States Army.

5 (7) Those who value freedom will forever owe Sergeant
6 Rimer a debt that never can be repaid.

7 (b) Designation.--The section of Harvey Run Road between
8 State Route 2004 in New Sewickley Township to Pennsylvania Route
9 65 in Freedom Borough, Beaver County, is designated the Army
10 Sergeant Joshua James Rimer Memorial Road.

11 (c) Signs.--The Department of Transportation shall erect and
12 maintain appropriate signs displaying the name of the highway to
13 traffic in both directions on the highway.

14 Section 23. Veterans of Slippery Rock Bridge.

15 (a) Designation.--The bridge identified as Bridge Key 7890
16 on that portion of Pennsylvania Route 108 in Worth Township,
17 Butler County, spanning Interstate 79 is designated the Veterans
18 of Slippery Rock Bridge.

19 (b) Signs.--The Department of Transportation shall erect and
20 maintain appropriate signs displaying the name of the bridge to
21 traffic in both directions on the bridge.

22 Section 24. Lieutenant Colonel William A. Rush III Memorial
23 Interchange.

24 (a) Findings.--The General Assembly finds that:

25 (1) Lieutenant Colonel William Alexander Rush III, born
26 September 14, 1946, in Kittanning, was a man devoted to God
27 and country.

28 (2) Lieutenant Colonel Rush's uncle, Orville Dawson, was
29 one of the first members of the Office of Strategic Services
30 (OSS), which was founded in 1943 during World War II. OSS was
31 the predecessor to the Central Intelligence Agency.

32 (3) Lieutenant Colonel Rush joined the United States
33 Marine Corps and became a pilot after graduating from flight
34 school in Pensacola, Florida.

35 (4) In September 1971, then Lieutenant Rush was sent to
36 Marine Corps Air Station Futenma, Ginowan, Okinawa, Japan,
37 and went on to serve from January 1972 through February 1972
38 in Vietnam, where he survived being shot down three times.
39 Due to the confidential nature of his assignments, the time
40 he spent serving his country in Vietnam was kept secret for
41 46 years.

42 (5) As a young Marine officer, Lieutenant Rush was often
43 called on to perform duties that were of a classified nature
44 by the intelligence community.

45 (6) After leaving the United States Marine Corps in
46 1975, then Captain Rush attended seminary school in
47 Gettysburg. Captain Rush later joined the United States Air
48 Force, serving active duty and in the reserves, where he rose
49 to the rank of Lieutenant Colonel as a chaplain.

50 (7) In the wake of the terrorist attacks on September
51 11, 2001, Lieutenant Colonel Rush again volunteered to serve

1 his country and went on active duty. He was assigned to
2 Tyndall Air Force Base in Florida, where he served as senior
3 chaplain of the 1st Air Force. Much like his previous
4 service, Lieutenant Colonel Rush had access to confidential
5 material and sat in on all security briefings. As a result,
6 Lieutenant Colonel Rush was not permitted to communicate with
7 his family.

8 (8) Lieutenant Colonel Rush was a direct blood
9 descendent of Dr. Benjamin Rush, a Founding Father of the
10 United States of America and signer of the Declaration of
11 Independence.

12 (9) Lieutenant Colonel Rush passed away March 2, 2021,
13 at home in Indiana, Pennsylvania.

14 (10) Lieutenant Colonel William Alexander Rush III's
15 service to his country, much of which remains a secret due to
16 the confidential nature of his service, deserves to be
17 recognized.

18 (b) Designation.--The interchange of U.S. Route 119 with
19 U.S. Route 422 in White Township, Indiana County, is designated
20 the Lieutenant Colonel William A. Rush III Memorial Interchange.

21 (c) Signs.--The Department of Transportation shall erect and
22 maintain appropriate signs displaying the name of the
23 interchange to traffic in both directions on the interchange.
24 Section 25. Scott F. Hirsh Memorial Interchange.

25 (a) Findings.--The General Assembly finds that:

26 (1) Scott F. Hirsh was born in Pittsburgh on July 24,
27 1962, and was a resident of Whitehall Borough, Allegheny
28 County.

29 (2) He was a cardiac care nurse at Jefferson Regional
30 Medical Center where he was loved and respected by everyone
31 with whom he interacted.

32 (3) On October 5, 2017, Scott Hirsh was traveling
33 northbound on I-279 in Ohio Township, Allegheny County, when
34 he experienced issues with a camper his vehicle was towing.

35 (4) As he was changing the tire on the camper, a
36 distracted driver swerved from the far-left lane, across all
37 travel lanes, and fatally struck him.

38 (5) Despite pulling off as far into the shoulder as
39 possible and correctly and adequately displaying safety
40 markings (i.e. blinkers, road flares, caution signs), Scott
41 Hirsh did not make it home alive to his family that night.

42 (b) Designation.--The interchange located on I-279 at Camp
43 Horne Road in Ohio Township, Allegheny County, is designated the
44 Scott F. Hirsh Memorial Interchange.

45 (c) Signs.--The Department of Transportation shall erect and
46 maintain appropriate signs displaying the name of the
47 interchange to traffic in both directions on the interchange.
48 Section 26. Chief of Police Tony M. Jordan Memorial Highway.

49 (a) Findings.--The General Assembly finds and declares as
50 follows:

51 (1) Chief of Police Tony M. Jordan was born on November

1 15, 1960, in Lewistown, Pennsylvania.

2 (2) Chief Jordan graduated from Middleburg High School
3 in 1978 and graduated from the Pennsylvania State Police
4 Municipal Academy in Hershey, Pennsylvania.

5 (3) Chief Jordan joined the Middleburg Police Department
6 in March 1980 and was appointed as the Middleburg Police
7 Chief of Police in August 1992.

8 (4) Chief Jordan established Jordan's PA K-9 Academy in
9 1981 and operated the organization until his passing.

10 (5) Chief Jordan died on January 13, 2021, as a result
11 of COVID-19.

12 (b) Designation.--The portion of Pennsylvania Route 104,
13 from the southern border of the Borough of Middleburg to the
14 northern border of the Borough of Middleburg, Snyder County, is
15 designated the Chief of Police Tony M. Jordan Memorial Highway.

16 (c) Signs.--The Department of Transportation shall erect and
17 maintain appropriate signs displaying the name of the highway to
18 traffic in both directions on the highway.

19 Section 27. Senator Stewart J. Greenleaf Memorial Interchange.

20 (a) Findings.--The General Assembly finds and declares as
21 follows:

22 (1) Born October 4, 1939, Senator Stewart J. Greenleaf
23 was raised in Willow Grove and was a lifelong resident of
24 Upper Moreland Township.

25 (2) Senator Greenleaf was a graduate of Upper Moreland
26 High School, the University of Pennsylvania and the
27 University of Toledo School of Law.

28 (3) Senator Greenleaf served in the Montgomery County
29 District Attorney's Office, where he rose to Chief of the
30 Appeals Unit, and was elected Chair of the Upper Moreland
31 Board of Commissioners.

32 (4) In 1976, Senator Greenleaf was elected to a seat in
33 the Pennsylvania House of Representatives to serve the 152nd
34 District.

35 (5) In 1978, Senator Greenleaf was first elected to the
36 Pennsylvania Senate and ultimately served for 10 terms over
37 the next 40 years until his retirement in 2018.

38 (6) Labeled a "Giant of the Legislature," Senator
39 Greenleaf sponsored 161 bills that were signed into law and
40 cosponsored 327 other bills.

41 (7) Senator Greenleaf served on the Senate
42 Appropriations Committee, Senate Banking and Insurance
43 Committee, Senate Consumer Protection and Professional
44 Licensure Committee and the Senate Environmental Resources
45 and Energy Committee.

46 (8) Senator Greenleaf's most significant impact on
47 public policy in Pennsylvania emanated from his long-time
48 chairmanship of the Senate Judiciary Committee, where he
49 sponsored provisions to allow child crime victims to testify
50 via closed-circuit television, Pennsylvania's Clean Indoor

1 Air Act and Pennsylvania's Megan's Law.

2 (9) Senator Greenleaf was a passionate champion of
3 criminal justice reforms in Pennsylvania long before such
4 policies gained widespread public notice and support.

5 (10) Senator Greenleaf leaves a legacy as an advocate
6 for child victims and a champion of consumer protection.

7 (11) Outside of his Senate career, Senator Greenleaf's
8 leadership and dedication to improving our community and
9 Commonwealth are unparalleled.

10 (12) Few elected officials have had the legislative
11 impact that Senator Greenleaf has manifested across our
12 Commonwealth and his work, integrity and devotion to duty
13 make this honor appropriate.

14 (13) On February 9, 2021, Senator Stewart J. Greenleaf
15 passed away at the age of 81.

16 (b) Designation.--The interchange of Interstate 276, also
17 known as the Pennsylvania Turnpike, with Pennsylvania Route 611,
18 also known as Exit 343, and the Willow Grove Interchange, in
19 Upper Moreland Township, Montgomery County, is designated the
20 Senator Stewart J. Greenleaf Memorial Interchange.

21 (c) Signs.--The Pennsylvania Turnpike Commission shall erect
22 and maintain appropriate signs displaying the name of the
23 interchange to traffic in both directions on the interchange.
24 Section 28. CPL William Glen Imler Memorial Bridge.

25 (a) Findings.--The General Assembly finds and declares as
26 follows:

27 (1) CPL Imler was born in Imlertown on November 26,
28 1915.

29 (2) CPL Imler graduated from Bedford High School in
30 1935.

31 (3) CPL Imler worked as a mason with his father until he
32 was inducted into the United States Army on September 23,
33 1941.

34 (4) CPL Imler completed basic training at Camp Wheeler,
35 Georgia, and from there was sent to Ft. Leonard Wood,
36 Missouri.

37 (5) In September of 1943, CPL Imler was sent to the
38 Hawaiian Islands and in February 1944 landed in New Guinea.

39 (6) On June 2, 1944, CPL Imler was killed in action in
40 New Guinea at 29 years of age.

41 (7) CPL Imler was awarded the Silver Star, Purple Heart,
42 World War II Victory Medal and the Honorable Service Lapel
43 Pin.

44 (b) Designation.--The bridge, identified as Bridge Key 4142,
45 carrying State Route 1001 over the Dunning Creek in the Borough
46 of Bedford, Bedford County, is designated the CPL William Glen
47 Imler Bridge.

48 (c) Signs.--The Department of Transportation shall erect and
49 maintain appropriate signs displaying the name of the bridge to
50 traffic in both directions on the bridge.

51 Section 29. Regis L. Stephenson Memorial Highway.

1 (a) Findings.--The General Assembly finds and declares as
2 follows:

3 (1) On January 8, 1951, Regis L. Stephenson was born in
4 Duquesne, Allegheny County.

5 (2) Mr. Stephenson was a graduate of Duquesne High
6 School, received his bachelor's degree in special education
7 from California University of Pennsylvania and received his
8 master's in education from Duquesne University.

9 (3) Mr. Stephenson taught special education in the
10 Pittsburgh Public School system for 32 years until his
11 retirement.

12 (4) For 20 years, Mr. Stephenson served on the West
13 Mifflin Borough Council and was serving as council president
14 at the time of his passing.

15 (5) In 1986, Mr. Stephenson began a six-year tenure on
16 the West Mifflin School Board.

17 (6) Additionally, Mr. Stephenson started the Pittsburgh
18 area's first troop for Boy Scouts with a disability and
19 served as a West Penn basketball official for 26 years.

20 (7) On May 15, 2012, Mr. Stephenson passed away at the
21 age of 61.

22 (b) Designation.--The section of State Route 2044, also
23 known as Brierly Lane, between Homestead-Duquesne Road and
24 Interboro Avenue in West Mifflin Borough, Allegheny County, is
25 designated the Regis L. Stephenson Memorial Highway.

26 (c) Signs.--The Department of Transportation shall erect and
27 maintain appropriate signs displaying the name of the highway to
28 traffic in both directions on the highway.
29 Section 30. Joyce Maureen Steele Memorial Highway.

30 (a) Findings.--The General Assembly finds and declares as
31 follows:

32 (1) Joyce Maureen Steele was born on December 25, 1935.

33 (2) Ms. Steele was a utility infielder/outfielder who
34 played in the All-American Girls Professional Baseball
35 League.

36 (3) Ms. Steele was a member of the Kalamazoo Lassies
37 Club during its 1953 season, while playing briefly at first
38 base and outfield.

39 (4) Ms. Steele died on April 21, 2019.

40 (b) Designation.--The entire length of State Route 4010 in
41 North Branch Township, Wyoming County, is designated the Joyce
42 Maureen Steele Memorial Highway.

43 (c) Signs.--The Department of Transportation shall erect and
44 maintain appropriate signs displaying the name of the highway to
45 traffic in both directions on the highway.
46 Section 31. Colonel Henry Bossert Memorial Bridge.

47 (a) Findings.--The General Assembly finds and declares as
48 follows:

49 (1) Colonel Henry Bossert was born January 15, 1825, in
50 Northampton County.

51 (2) Colonel Bossert attended Lafayette College in

1 Easton.

2 (3) During the Civil War, Colonel Bossert commanded the
3 11th PA Infantry Regiment, the 137th PA Infantry Regiment,
4 the 1st Brigade, 2nd Division, 6th Army Corps of the Army of
5 the Potomac and the 3rd Brigade, 1st Division, 1st Army Corps
6 of the Army of the Potomac.

7 (4) Colonel Bossert engaged in battle at Fredericksburg
8 and Antietam during the Maryland Campaign.

9 (5) Colonel Bossert's calmness and bravery at the Battle
10 of Antietam in the face of harsh combat and adversity was
11 critical to the Union's strategic victory on that day.

12 (6) Colonel Bossert died on January 23, 1892, in
13 Westport.

14 (b) Designation.--The bridge, identified as Bridge Key
15 12165, carrying Pennsylvania Route 150 over the Bald Eagle
16 Creek, in Bald Eagle Township, Clinton County, is designated the
17 Colonel Henry Bossert Memorial Bridge.

18 (c) Signs.--The Department of Transportation shall erect and
19 maintain appropriate signs displaying the name of the bridge to
20 traffic in both directions on the bridge.

21 Section 32. Honorable Robert W. Godshall Memorial Highway.

22 (a) Findings.--The General Assembly finds and declares as
23 follows:

24 (1) Robert W. Godshall was born May 15, 1933, in
25 Souderton, Montgomery County, and lived on the same farm for
26 his entire life.

27 (2) Mr. Godshall graduated from Souderton High School in
28 1951 and from Juniata College in 1955 with a bachelor of
29 science degree in business administration.

30 (3) Mr. Godshall later attended graduate school at The
31 Wharton School at the University of Pennsylvania until called
32 home to help run the family's poultry farm due to his
33 father's poor health.

34 (4) Mr. Godshall became and continued on as president of
35 Godshall's Hatchery until 1990.

36 (5) In 1962, Mr. Godshall began a 32-year tenure as a
37 Republican committeeman serving as area leader from 1970
38 until his death.

39 (6) In 1963, Mr. Godshall was elected to the Souderton
40 Area School Board and served until 1980.

41 (7) Mr. Godshall also served as the Montgomery County
42 Open Space director from 1975 to 1979, and as Montgomery
43 County controller from 1980 to 1983 where he oversaw the
44 county's pension fund.

45 (8) In 1982, Mr. Godshall was elected to the
46 Pennsylvania House of Representatives where he served the
47 53rd Legislative District for 36 years until retirement in
48 2018.

49 (9) Of Mr. Godshall's many accomplishments, several
50 stood out as points of pride for him, including the
51 construction of the Point Pleasant Pumping Station, the

1 development of the National Constitution Center where he
2 served on the board of directors for 12 years and several
3 legislation successes, including the 2017 enactment of his
4 Right to Try legislation, legislation phasing in electric
5 rate increases after rate caps were lifted, protecting those
6 on fixed incomes and his work on medical malpractice
7 regulations.

8 (10) In 2011, Mr. Godshall received the American Hero
9 Award from the National Kidney Registry for his
10 groundbreaking legislation on behalf of organ donors.

11 (11) On November 24, 2019, Robert Godshall passed away
12 at the age of 86.

13 (b) Designation.--The section of Pennsylvania Route 113 from
14 its intersection with Schoolhouse Road, in Franconia Township,
15 Montgomery County, and State Route 4027, also known as County
16 Line Road, in Souderton Borough, Montgomery County, is
17 designated the Honorable Robert W. Godshall Memorial Highway.

18 (c) Signs.--The Department of Transportation shall erect and
19 maintain appropriate signs displaying the name of the highway to
20 traffic in both directions on the highway.

21 Section 33. Private First Class Lee David Meadows Memorial
22 Bridge.

23 (a) Findings.--The General Assembly finds and declares as
24 follows:

25 (1) Private First Class Lee David Meadows was born on
26 October 1, 1951, in Johnstown.

27 (2) PFC Meadows graduated from Ferndale High School in
28 1969, where he was a talented and active musician in the
29 school's band and known for his skills playing the tuba.

30 (3) After graduation, PFC Meadows served in the Army's
31 3rd Squadron, 17th Cavalry, 1st Aviation Brigade, as an
32 observation/scout helicopter repairer.

33 (4) At the young age of 18, PFC Meadows was killed in
34 the line of duty when his helicopter was shot down in the
35 Quang Tri Province of South Vietnam on September 15, 1970.

36 (b) Designation.--The bridge, identified as Bridge Key 8517,
37 carrying Pennsylvania Route 403 over the Stonycreek River in
38 Ferndale Borough, Cambria County, is designated the Private
39 First Class Lee David Meadows Memorial Bridge.

40 (c) Signs.--The Department of Transportation shall erect and
41 maintain appropriate signs displaying the name of the bridge to
42 traffic in both directions on the bridge.

43 Section 34. John K. Weaver Memorial Bridge.

44 (a) Findings.--The General Assembly finds and declares as
45 follows:

46 (1) John K. Weaver was born June 24, 1951, in Denver,
47 Pennsylvania.

48 (2) Mr. Weaver was the husband of Yvonne Weaver for 45
49 years and the couple shared three sons and four
50 grandchildren.

51 (3) Mr. Weaver was the owner and operator of Weaver

1 Industries and served as president for over 30 years.

2 (4) Weaver Industries was started by John's father
3 Harold S. Weaver in 1954 and provides 76 jobs within the
4 local community.

5 (5) Mr. Weaver was a lifetime member of the Denver Fire
6 Department where he served for over 50 years.

7 (6) Mr. Weaver passed away on January 25, 2019.

8 (b) Designation.--The bridge, identified as Bridge Key
9 56645, carrying State Route 1045, also known as South 4th
10 Street, over Cocalico Creek in the Borough of Denver, Lancaster
11 County, is designated the John K. Weaver Memorial Bridge.

12 (c) Signs.--The Department of Transportation shall erect and
13 maintain appropriate signs displaying the name of the bridge to
14 traffic in both directions on the bridge.

15 Section 35. Fichthorn and Marburger Memorial Bridge.

16 (a) Findings.--The General Assembly finds and declares as
17 follows:

18 (1) Samuel E. Fichthorn, Daniel E. Fichthorn and Ambrose
19 Marburger were the founders of the F&M Hat Company.

20 (2) In 1912, the F&M Hat Company was incorporated in
21 Denver, Pennsylvania.

22 (3) The F&M Hat Company was a pioneer in harnessing
23 steam power for wool felt hat manufacturing.

24 (b) Designation.--The bridge, identified as Bridge Key
25 21481, carrying State Route 1051, also known as Main Street,
26 over Little Cocalico Creek in the Borough of Denver, Lancaster
27 County, is designated the Fichthorn and Marburger Memorial
28 Bridge.

29 (c) Signs.--The Department of Transportation shall erect and
30 maintain appropriate signs displaying the name of the bridge to
31 traffic in both directions on the bridge.

32 Section 36. Glenn A. Martin Memorial Highway.

33 (a) Findings.--The General Assembly finds and declares as
34 follows:

35 (1) Glenn A. Martin was born on June 4, 1942, in
36 Harrisburg and was a graduate of John Harris High School.

37 (2) In August of 1961, Mr. Martin enlisted in the United
38 States Army and became a military policeman.

39 (3) After acceptance into the Pennsylvania State Police,
40 Mr. Martin transferred his military service to the Army
41 National Guard and then to the Air National Guard.

42 (4) Mr. Martin retired from the 193rd Security Forces
43 Squadron of the Pennsylvania Air National Guard as a master
44 sergeant in 1993.

45 (5) In 1964, Mr. Martin became a Pennsylvania State
46 Police Trooper working most of his career in the Troop H
47 Harrisburg, Criminal Investigation Unit.

48 (6) During his 27 years of service, Mr. Martin helped
49 solve countless murders, including cracking the famous "Susan
50 Reinert" case in 1979.

51 (7) During his tenure, Mr. Martin also served as a

1 firearms instructor and an assistant fire marshal.

2 (8) After 27 years of service, Mr. Martin retired from
3 the Pennsylvania State Police in January 1992.

4 (9) Mr. Martin passed away from brain cancer on January
5 29, 2021, after a lifetime as a civil servant.

6 (10) Mr. Martin left an unimpeachable positive impact on
7 the world.

8 (b) Designation.--The section of State Route 2019 known as
9 Nyes Road, from the intersection of Derry Street to the
10 intersection of Union Deposit, in Swatara and Lower Paxton
11 Townships, Dauphin County, is designated the Glenn A. Martin
12 Memorial Highway.

13 (c) Signs.--The Department of Transportation shall erect and
14 maintain appropriate signs displaying the name of the highway to
15 traffic in both directions on the highway.

16 Section 37. Westline Veterans Memorial Bridge.

17 (a) Findings.--The General Assembly finds and declares as
18 follows:

19 (1) The Commonwealth and this nation are indebted to the
20 veterans of Westline for their bravery, heroism and
21 sacrifices in protecting freedom and liberty both at home and
22 abroad.

23 (2) It is with the highest level of gratitude and
24 respect that the community of Westline request this
25 designation to honor the past, present and future veterans of
26 Westline.

27 (b) Designation.--The bridge, identified as Bridge Key
28 25507, on that portion of State Route 3006 over the Kinzua Creek
29 in the census-designated place of Westline, Lafayette Township,
30 McKean County, is designated the Westline Veterans Memorial
31 Bridge.

32 (c) Signs.--The Department of Transportation shall erect and
33 maintain appropriate signs displaying the name of the bridge to
34 traffic in both directions on the bridge.

35 Section 38. Lieutenant Joseph O. Stevens Memorial Bridge.

36 (a) Findings.--The General Assembly finds that:

37 (1) Joseph O. Stevens was born July 14, 1922, in
38 Orbisonia Borough, Huntingdon County.

39 (2) As a lieutenant, he was a pilot in the 9th U.S. Army
40 Air Corps, 387th Bomb Group, 559th Squadron, and served in
41 the Ardennes, Rhineland and Central Europe where he was
42 awarded the Silver Star and an Air Medal with four Oak Leaf
43 Clusters.

44 (3) He was a member of Madden-Winnick Post 518 American
45 Legion, Orbisonia, and the Blue Juniata VFW Post 5754, Mount
46 Union.

47 (4) Lt. Stevens graduated from the University of
48 Pennsylvania in 1952 with a Doctor of Dental Surgery degree
49 (DDS) and practiced as a dentist in Orbisonia for 50 years
50 until retirement.

51 (5) Lt. Stevens was a former Boy Scout leader, was

1 active in the Southern Huntingdon County High School Booster
2 Club and was instrumental in the establishment of the
3 Huntingdon County Vo-Tech School, now the Huntingdon County
4 Career and Technology Center.

5 (6) Lt. Joseph O. Stevens died January 26, 2020, at the
6 Hollidaysburg Veterans' Home.

7 (b) Designation.--The bridge on that portion of State Route
8 994 over the Blacklog Creek, Cromwell Township, Huntingdon
9 County, is designated the Lieutenant Joseph O. Stevens Memorial
10 Bridge.

11 (c) Signs.--The Department of Transportation shall erect and
12 maintain appropriate signs displaying the name of the bridge to
13 traffic in both directions on the bridge.

14 Section 39. SPC John Kulick Memorial Highway.

15 (a) Findings.--The General Assembly finds and declares as
16 follows:

17 (1) SPC John Kulick began his distinguished firefighting
18 career when he joined the Enterprise Fire Company as a 16-
19 year-old junior firefighter in 1985, and subsequently rose to
20 the rank of deputy chief.

21 (2) He later became a Federal Firefighter at the now
22 closed Johnsville Naval Air Warfare Center in Warminster,
23 Pennsylvania.

24 (3) Upon closing, he was transferred to the Naval Air
25 Station Willow Grove.

26 (4) He subsequently became a career firefighter for the
27 Whitpain Township Fire Department in Montgomery County, where
28 he also served as the township's assistant fire marshal.

29 (5) After the tragic events of September 11, 2001, SPC
30 John Kulick was moved to join the Pennsylvania National Guard
31 in September 2003. He was deployed to Iraq shortly after he
32 completed boot camp.

33 (6) He was assigned to the 1st Battalion, 111th Infantry
34 Regiment (Mechanized), Pennsylvania Army National Guard of
35 Philadelphia.

36 (7) On August 9, 2005, while serving during Operation
37 Iraqi Freedom, SPC John Kulick was killed at 35 years of age,
38 along with three of his fellow soldiers, when a mine exploded
39 and enemy forces attacked using small arms fire as they were
40 investigating a rocket-propelled grenade incident in Bayji,
41 Iraq.

42 (b) Designation.--The portion of State Route 2009, also
43 known as Byberry Road, between State Route 2040, also known as
44 Warminster Road, and State Route 263, also known as Old York
45 Road, in Hatboro Borough, Montgomery County, is designated the
46 SPC John Kulick Memorial Highway.

47 (c) Signs.--The Department of Transportation shall erect and
48 maintain appropriate signs displaying the name of the highway to
49 traffic in both directions on the highway.

50 Section 40. Honorable George C. Hasay Memorial Highway.

51 (a) Findings.--The General Assembly finds and declares as

1 follows:

2 (1) George C. Hasay was born February 7, 1948.

3 (2) Mr. Hasay was a 1966 graduate of Northwest Area High
4 School.

5 (3) After graduating from high school, Mr. Hasay
6 attended the Wilkes-Barre Business College and Husson College
7 in Bangor, Maine.

8 (4) At the age of seven, Mr. Hasay started washing cars
9 for his father's Chevrolet dealership, the former Hasay
10 Chevrolet.

11 (5) Mr. Hasay worked for the family business as a car
12 salesman before becoming elected to serve in the House of
13 Representatives in 1972 at the age of 23.

14 (6) At the time of Mr. Hasay's election, he became the
15 youngest member of the House of Representatives and then
16 became the longest serving member, 34 years, before retiring
17 in 2006.

18 (7) As a legislator, Mr. Hasay dedicated his time
19 working on the Conservation Committee, Commerce Committee and
20 Rules Committee.

21 (8) In retirement, Mr. Hasay continued his civic duty of
22 serving others through volunteering as a member of the AACA
23 Museum, board of directors of the Northern Columbia County
24 Community and Cultural Center, Sylvania Lodge No. 354 and the
25 Chimney Stack Rod and Hunting Club.

26 (9) Mr. Hasay passed away on February 8, 2021, at the
27 age of 73 years old.

28 (b) Designation.--The portion of U.S. Route 11, also known
29 as Main Street, from Segment 200, Offset 0000 to the
30 intersection with Oak Street in Shickshinny Borough, Luzerne
31 County, is designated the Honorable George C. Hasay Memorial
32 Highway.

33 (c) Signs.--The Department of Transportation shall erect and
34 maintain appropriate signs displaying the name of the highway to
35 traffic in both directions on the highway.
36 Section 41. Bryan T. "Chipper" Chamberlain Memorial Bridge.

37 (a) Findings.--The General Assembly finds and declares as
38 follows:

39 (1) Bryan T. Chamberlain was born on December 28, 1987.

40 (2) Mr. Chamberlain was a 2006 graduate of Claysburg-
41 Kimmel High School.

42 (3) Mr. Chamberlain was an equipment operator at PennDOT
43 for five years and was previously employed at New Enterprise
44 Stone and Lime Company.

45 (4) In his spare time, Mr. Chamberlain enjoyed hunting,
46 fishing, bowfishing and working on his family's farm.

47 (5) Mr. Chamberlain passed away on August 30, 2018, as a
48 result of injuries from a work-related accident.

49 (6) The Commonwealth is indebted to Mr. Chamberlain and
50 all employees who work to make Pennsylvania roadways safer.

51 (b) Designation.--The bridge, identified as Bridge Key 5786,

1 carrying State Route 3013, known as Dunnings Highway, over South
2 Poplar Run, in Greenfield Township, Blair County, is designated
3 the Bryan T. "Chipper" Chamberlain Memorial Bridge.

4 (c) Signs.--The Department of Transportation shall erect and
5 maintain appropriate signs displaying the name of the bridge to
6 traffic in both directions on the bridge.

7 Section 42. Joseph Caviston Memorial Bridge.

8 (a) Findings.--The General Assembly finds and declares as
9 follows:

10 (1) Joseph Caviston was born in Carbondale to John and
11 Helen Caviston and was a graduate of St. Rose of Lima High
12 School, Carbondale.

13 (2) Joseph Caviston served as an employee of the
14 Pennsylvania Department of Transportation.

15 (3) On October 8, 1974, the rear of Joseph Caviston's
16 truck was hit by a vehicle while he was directing traffic to
17 the passing lane to protect other workers stationed on the
18 berm along Interstate 81 in Greenfield Township, Lackawanna
19 County, causing both vehicles to turn over.

20 (4) As a result of the injuries he sustained in this
21 collision, Joseph Caviston went into a coma and passed away
22 six months later on April 18, 1975, at the age of 35.

23 (b) Designation.--The bridge, identified as Bridge Key
24 20703, on State Route 1039, also known as Meredith Street, over
25 Gordan Avenue and Lackawanna Avenue in Carbondale Township,
26 Lackawanna County, is designated the Joseph Caviston Memorial
27 Bridge.

28 (c) Signs.--The Department of Transportation shall erect and
29 maintain appropriate signs displaying the name of the bridge to
30 traffic in both directions on the bridge.

31 Section 43. SP4 James Wise, Jr., and PFC James Wingert USMC
32 Memorial Bridge.

33 (a) Findings.--The General Assembly finds and declares as
34 follows:

35 (1) SP4 James Wise, Jr., and PFC James Wingert, who grew
36 up together as next door neighbors in Big Run, Jefferson
37 County, gave their lives in service to their country during
38 the Vietnam War.

39 (2) SP4 James Wise, Jr., served with the United States
40 Army, 3rd Platoon, A Company, 1st Battalion, 4th Infantry
41 Division.

42 (3) PFC Wingert served with the United States Marine
43 Corps, E Company, 2nd Battalion, 5th Marines, 1st Marine
44 Division.

45 (4) On February 6, 1968, SP4 Wise was killed in action
46 in Kontum, South Vietnam.

47 (5) On August 23, 1969, PFC Wingert was killed in action
48 in Quang Nam, South Vietnam.

49 (b) Designation.--The bridge, identified by Bridge Key
50 19699, on that portion of State Route 2003 over Mahoning Creek
51 in Big Run Borough, Jefferson County, is designated the SP4

1 James Wise, Jr., and PFC James Wingert USMC Memorial Bridge.

2 (c) Signs.--The Department of Transportation shall erect and
3 maintain appropriate signs displaying the name of the bridge to
4 traffic in both directions on the bridge.

5 Section 44. Trooper Michael Stewart III Memorial Bridge.

6 (a) Findings.--The General Assembly finds and declares as
7 follows:

8 (1) Michael Stewart III was born on July 22, 1990, in
9 Latrobe, PA.

10 (2) Trooper Stewart graduated from Greater Latrobe
11 Senior High School in 2008 and went on to earn his bachelor's
12 degree from Indiana University of Pennsylvania in 2012.

13 (3) Trooper Stewart graduated from the Pennsylvania
14 State Police Academy, Class 138, and served as a trooper with
15 the Chambersburg and Greensburg barracks.

16 (4) Trooper Michael Stewart III died on July 14, 2017,
17 in the line of duty.

18 (b) Designation.--The bridge, identified as Bridge Key
19 36313, carrying Pennsylvania Route 981, also known as Lloyd
20 Avenue, over Loyalhanna Creek in Latrobe, Westmoreland County,
21 is designated the Trooper Michael Stewart III Memorial Bridge.

22 (c) Signs.--The Department of Transportation shall erect and
23 maintain appropriate signs displaying the name of the bridge to
24 traffic in both directions on the bridge.

25 Section 45. Corporal Cecil J. Snyder Memorial Bridge.

26 (a) Findings.--The General Assembly finds and declares as
27 follows:

28 (1) Cpl. Cecil J. Snyder was born in Lyleville outside
29 of Coalport, Clearfield County.

30 (2) In May 1939, Cpl. Snyder enlisted in the United
31 States Army Air Corps where he received specialized training
32 as a technician.

33 (3) At the outbreak of World War II, Cpl. Snyder served
34 in the Pacific Theater, defending the Philippine Islands.

35 (4) Cpl. Snyder and many of his fellow soldiers were
36 taken prisoner by the Japanese when their base was captured.

37 (5) Cpl. Snyder was taken to Palawan Prison Camp where
38 he and other prisoners were forced to work as slave labor
39 building an airfield for the Japanese.

40 (6) On December 14, 1944, fearing the capture of the
41 island by the advancing Allies, the Japanese High Command
42 ordered all the prisoners to be killed.

43 (7) Cpl. Snyder and 144 soldiers were killed in what is
44 now known as the Palawan Massacre.

45 (8) Cpl. Snyder's remains were repatriated to the United
46 States and interred at the Jefferson Barracks National
47 Cemetery in St. Louis, Missouri, in February 1952.

48 (9) Cpl. Snyder is also memorialized at his family plot
49 in Lyleville Cemetery.

50 (10) Cpl. Snyder received many commendations for his
51 service, including the Purple Heart, World War II Victory

1 Medal, American Campaign Medal, Army Presidential Unit
2 Citation, Army Good Conduct Medal and the Asiatic-Pacific
3 Campaign Medal.

4 (b) Designation.--The bridge, identified as Bridge Key
5 11802, carrying State Route 3008 over Clearfield Creek, Beccaria
6 Township, Clearfield County, is designated the Corporal Cecil J.
7 Snyder Memorial Bridge.

8 (c) Signs.--The Department of Transportation shall erect and
9 maintain appropriate signs displaying the name of the bridge to
10 traffic in both directions on the bridge.

11 Section 46. Cambria County Vietnam Veterans Memorial Bridge.

12 (a) Findings.--The General Assembly finds and declares that
13 this Commonwealth and the nation are indebted to the Vietnam
14 veterans of Cambria County for their bravery, heroism and
15 sacrifice in protecting freedom and liberty both at home and
16 abroad.

17 (b) Designation.--The bridge, identified as Bridge Key
18 41673, carrying Oakridge Drive (State Route 3102) over U.S. 219
19 in Richland Township, Cambria County, is designated the Cambria
20 County Vietnam Veterans Memorial Bridge.

21 (c) Signs.--The Department of Transportation shall erect and
22 maintain appropriate signs displaying the name of the bridge to
23 traffic in both directions on the bridge.

24 Section 47. Firefighter Thomas Royds Memorial Highway.

25 (a) Findings and declarations.--The General Assembly finds
26 and declares as follows:

27 (1) A career firefighter, Thomas Royds was born on
28 October 7, 1972, in Philadelphia.

29 (2) Mr. Royds grew up in Belmont Hills where he
30 graduated from Harriton High School and earned his
31 associate's degree from Delaware Community College.

32 (3) In 1988, Mr. Royds started his fire-fighting career
33 as a volunteer with the Union Fire Association of Lower
34 Merion and the Belmont Hills Fire Company, following in both
35 his father's and grandfather's footsteps.

36 (4) In 2014, Mr. Royds joined the Clifton Heights Fire
37 Company as a volunteer firefighter where he held various
38 leadership positions over the last five years, most recently
39 holding the rank of captain.

40 (5) Mr. Royds was a proud member of the Lower Merion
41 Professional Firefighters Association International
42 Association of Fire Fighters Local 2844, and served with the
43 Lower Merion Fire Department.

44 (6) In 2019, after over 30 years of service, Mr. Royds
45 was brought on as a full-time career firefighter at the Union
46 Fire Association of Lower Merion, where he had previously
47 earned the rank of Captain as a volunteer, and served as the
48 Company's career Lieutenant. Mr. Royds also served as a
49 career firefighter/driver with the Belmont Hills Fire
50 Company.

51 (7) At one point or another during his career, Mr. Royds

1 held every board position for the Union Fire Association of
2 Lower Merion's Active Members Club.

3 (8) On July 24, 2021, Firefighter Thomas Royds was
4 struck and killed by a motorist while responding with the
5 Belmont Hills Fire Company to an accident on the Schuylkill
6 Expressway at the age of 48.

7 (9) On July 27, 2021, the Governor ordered the
8 Commonwealth flag on all Commonwealth facilities, public
9 buildings and grounds in Montgomery County to fly at half-
10 staff in honor of Firefighter Thomas Royds.

11 (b) Designation.--The portion of Interstate 76, also known
12 as the Schuylkill Expressway, from mile marker 334.5 to mile
13 marker 335.5 in Lower Merion Township, Montgomery County, is
14 designated the Firefighter Thomas Royds Memorial Highway.

15 (c) Signs.--The Department of Transportation shall erect and
16 maintain appropriate signs displaying the name of the highway to
17 traffic in both directions on the highway.
18 Section 48. William G. Carpenter Highway.

19 (a) Findings.--The General Assembly finds and declares as
20 follows:

21 (1) William G. Carpenter was born January 28, 1946, in
22 Lebanon County.

23 (2) Mr. Carpenter graduated from Cornwall High School in
24 1964.

25 (3) Mr. Carpenter distinguished himself as an honorable
26 veteran with notable military accomplishments, having served
27 as a Private First Class E-3 soldier in the United States
28 Army HHC, 1st Battalion, 35th Infantry, from March 15, 1966,
29 to March 14, 1968.

30 (4) Mr. Carpenter was a recipient of the Good Conduct
31 Medal, the Combat Infantryman Badge, the National Defense
32 Service Medal, the Vietnam Service Medal, the Vietnam
33 Campaign Medal, the Purple Heart Award, an Overseas Service
34 Bar and the Silver Star Medal.

35 (5) Throughout Mr. Carpenter's life, he has achieved
36 many significant accomplishments in his community, including
37 his service as a Lebanon County Commissioner for 24 years and
38 as a member of the Cornwall Borough Council for 16 years.

39 (6) Mr. Carpenter was nominated as "Man of the Year" by
40 Mt. Gretna Rotary in 1981 and was a recipient of the "Service
41 to Mankind Award" by Hershey/Palmyra Sertoma in 2000.

42 (7) In 2002, Mr. Carpenter was nominated as a Torch
43 Bearer at the International Olympic Games.

44 (b) Designation.--The section of Pennsylvania Route 72 from
45 Segment 0010/Offset 0000 to Segment 0110/Offset 1330 in Cornwall
46 Borough, Lebanon County, is designated the William G. Carpenter
47 Highway.

48 (c) Signs.--The Department of Transportation shall erect and
49 maintain appropriate signs displaying the name of the highway to
50 traffic in both directions on the highway.
51 Section 49. Corporal Ralph Hammel Memorial Bridge.

1 (a) Findings.--The General Assembly finds and declares as
2 follows:

3 (1) Corporal Ralph Hammel was born on May 8, 1947, in
4 Roaring Spring Pennsylvania.

5 (2) Prior to enlisting in the United States Marine
6 Corps, Cpl. Hammel attended Hollidaysburg Area High School.

7 (3) Cpl. Hammel served as part of the 1st Battalion, 3rd
8 Marine Division.

9 (4) On March 7, 1968, Cpl. Hammel died as a result of
10 wounds sustained in combat from enemy mortar fire in the Quan
11 Tri Province of South Vietnam.

12 (b) Designation.--The bridge, identified as Bridge Key
13 46159, carrying Pennsylvania Route 36 on Charger Highway, Blair
14 Township, Blair County, is designated the Corporal Ralph Hammel
15 Memorial Bridge.

16 (c) Signs.--The Department of Transportation shall erect and
17 maintain appropriate signs displaying the name of the bridge to
18 traffic in both directions on the bridge.

19 Section 50. Lazendorfer Brothers Memorial Bridge.

20 (a) Findings.--The General Assembly finds and declares as
21 follows:

22 (1) The Lazendorfer family settled in Blacklick
23 Township, Cambria County, and raised eight sons, Wilfred
24 John, Francis Henry, Robert Andrew, Paul Eugene, George
25 Russell, Thomas William, Richard Arthur and Dawn Edward.

26 (2) The Lazendorfer brothers distinguished themselves as
27 honorable veterans, all eight of them having served in the
28 United States military.

29 (3) The eldest son, Wilfred John Lazendorfer, entered
30 the United States Marine Corps in 1939 and the youngest son,
31 Dawn Edward Lazendorfer, entered the United States military
32 after his high school graduation.

33 (4) Four of the Lazendorfer brothers served in the
34 United States military during World War II, two brothers
35 served in the Korean War and the other two brothers served in
36 the United States military during peacetime.

37 (5) Throughout their lives, the Lazendorfer brothers had
38 many significant accomplishments in their community,
39 including the following:

40 (i) Wilfred Lazendorfer served as a tax collector
41 for many years.

42 (ii) George Lazendorfer served as a police chief of
43 Blacklick Township.

44 (iii) Robert Lazendorfer was postmaster of Twin
45 Rocks for 41 years.

46 (iv) Additionally, George Lazendorfer and his sons
47 were involved in the coal and trucking industries.

48 (6) Seven of the eight Lazendorfer brothers remained in
49 Twin Rocks, Cambria County, and one of the brothers moved
50 five miles away to Mundys Corner, Cambria County.

51 (b) Designation.--The bridge, identified as the Bridge Key

68510, carrying Pennsylvania Route 271 over Coal Pit Run in Blacklick Township, Cambria County, is designated the Lazendorfer Brothers Memorial Bridge.

(c) Signs.--The Department of Transportation shall erect and maintain appropriate signs displaying the name of the bridge to traffic in both directions on the bridge.

Section 51. Richard Paul Memorial Highway.

(a) Findings.--The General Assembly finds and declares as follows:

(1) Allen Richard Paul was a graduate of Marple Newtown Senior High and a resident of Marple Township, Delaware County, for 65 years.

(2) Mr. Paul served in the United States Navy during the Vietnam War.

(3) Mr. Paul was involved with local historic preservation efforts for 27 years, having served as Chairman of the Delaware County Heritage Commission, as President and then Treasurer of the Delaware County Historical Society and as Property Director and Vice President to the 1696 Thomas Massey House.

(4) Mr. Paul worked to gain funding for cleaning and preserving cemeteries that have long since been overgrown, most recently working with the African-American community to help clean up and recognize the Hayti Cemetery with a marker on the National Historic Register.

(5) Mr. Paul worked with State representatives to pass House Resolution No. 278 of 2019 designating May 4, 2019, as "Forgotten Cemetery Day" in Pennsylvania.

(6) Mr. Paul also worked diligently to found the Susan Lucas Scholarship Fund.

(7) An active member of the community, Mr. Paul also served as the Vice President of the Marple Little League from 1980 through 1981 and as the Scoutmaster of Boy Scout Troop 151 at the Marple Presbyterian Church from 1983 through 1988.

(8) Mr. Paul passed away on December 29, 2020, at the age of 77.

(b) Designation.--The portion of State Route 1020, also known as Lawrence Road, between Springhouse Road and Parkway Avenue in Marple Township, Delaware County, is designated the Richard Paul Memorial Highway.

(c) Signs.--The Department of Transportation shall erect and maintain appropriate signs displaying the name of the highway to traffic in both directions on the highway.

Section 52. PFC Robert Joseph Morris Memorial Bridge.

(a) Findings.--The General Assembly finds and declares as follows:

(1) Private First Class Robert Joseph Morris was born December 27, 1947.

(2) PFC Morris enlisted in the United States Army in February 1965 and took basic training at Ft. Jackson, South Carolina.

(3) PFC Morris served with the 25th Infantry Division in the Vietnam War and, at the age of 19, was killed in action on July 3, 1966, in the Gia Dinh province.

(4) PFC Morris was posthumously awarded the Bronze Star for Valor.

(b) Designation.--The bridge, identified as Bridge Key 68360, carrying State Route 2025, also known as Bristol Road, over U.S. Route 1 in Bensalem Township, Bucks County, is designated the PFC Robert Joseph Morris Memorial Bridge.

(c) Signs.--The Department of Transportation shall erect and maintain appropriate signs displaying the name of the bridge to traffic in both directions on the bridge.

Section 53. PFC Hopson Covington Memorial Bridge.

(a) Findings.--The General Assembly finds and declares as follows:

(1) Private First Class Hopson Covington was born October 20, 1943.

(2) PFC Covington was drafted into the United States Army and began his tour in Vietnam on August 21, 1967, with the 25th Infantry Division.

(3) PFC Covington was killed in action on December 29, 1967, in Tay Ninh province.

(4) PFC Covington was posthumously awarded the Bronze Star for Valor.

(b) Designation.--The bridge, identified as Bridge Key 67570, carrying State Route 2006, also known as New Falls Road, over the Pennsylvania Turnpike in Bristol Township, Bucks County, is designated the PFC Hopson Covington Memorial Bridge.

(c) Signs.--The Department of Transportation shall erect and maintain appropriate signs displaying the name of the bridge to traffic in both directions on the bridge.

Section 54. PFC George Raymond Huntzinger Memorial Bridge.

(a) Findings.--The General Assembly finds and declares as follows:

(1) Private First Class George Raymond Huntzinger was born July 5, 1945.

(2) PFC Huntzinger graduated from Neshaminy High School in 1968.

(3) PFC Huntzinger served in the United States Army and began his tour in Vietnam on September 11, 1969, serving with the 198th Light Infantry Brigade.

(4) PFC Huntzinger was killed in action in Quang Ngai province on October 29, 1969.

(b) Designation.--The bridge, identified as Bridge Key 7278, carrying State Route 2043, also known as Brownsville Road, over Neshaminy Creek in Lower Southampton Township, Bucks County, is designated the PFC George Raymond Huntzinger Memorial Bridge.

(c) Signs.--The Department of Transportation shall erect and maintain appropriate signs displaying the name of the bridge to traffic in both directions on the bridge.

Section 55. Army Specialist Four Harold Phillip Grasser

Memorial Bridge.

(a) Findings.--The General Assembly finds and declares as follows:

(1) Army Specialist Four Harold Phillip Grasser served in the United States Army during the Vietnam War and was a native of Manns Choice.

(2) Army Specialist Four Grasser was killed in action on August 30, 1968.

(b) Designation.--The bridge, identified as Bridge Key 46778, carrying State Route 3012, also known as New Baltimore Road, over Raystown Branch Juniata River in Juniata Township, Bedford County, is designated the Army Specialist Four Harold Phillip Grasser Memorial Bridge.

(c) Signs.--The Department of Transportation shall erect and maintain appropriate signs displaying the name of the bridge to traffic in both directions on the bridge.

Section 56. PFC James E. Williams Memorial Bridge.

(a) Findings.--The General Assembly finds and declares as follows:

(1) PFC James E. Williams, a native of Bedford County, gave his life in service to his country during the Korean War.

(2) PFC Williams served as a Light Weapons Infantryman with the 38th Infantry Regiment, 2nd Infantry Division.

(3) PFC Williams was captured and held by the Chinese as a prisoner of war for 27 months.

(4) On May 18, 1951, PFC Williams died while still in captivity.

(5) PFC Williams was awarded the Purple Heart for his valiant service.

(b) Designation.--The bridge, identified as Bridge Key 3937, carrying Pennsylvania Route 26 over Yellow Creek in Everett Borough, Bedford County, is designated the PFC James E. Williams Memorial Bridge.

(c) Signs.--The Department of Transportation shall erect and maintain appropriate signs displaying the name of the bridge to traffic in both directions on the bridge.

Section 57. Colonel Joseph M. Stine Memorial Bridge.

(a) Findings.--The General Assembly finds and declares as follows:

(1) Colonel Joseph M. Stine, a native of Everett, gave his life in service to his country during the Vietnam War.

(2) Colonel Stine joined the United States Air Force just a few days after graduating from Everett Area High School in 1949.

(3) Colonel Stine received his pilot wings in 1953 in Big Springs, Texas, and was commissioned as a 2nd Lieutenant.

(4) Colonel Stine was a T33 instructor pilot in Rio, Texas, for five years, and in 1959 was transferred to England, where he flew the B-66 for three years.

(5) On August 1, 1966, Colonel Stine was sent to

1 Vietnam, and, while flying a night photo mission over Hanoi
2 on September 27, 1966, his plane dropped off of radar and he
3 was never seen or heard from again.

4 (6) On March 6, 1978, Colonel Stine's status was changed
5 to killed in action.

6 (b) Designation.--The bridge, identified as Bridge Key
7 45676, carrying Pennsylvania Route 26 over Bloody Run in
8 Hopewell Township, Bedford County, is designated the Colonel
9 Joseph M. Stine Memorial Bridge.

10 (c) Signs.--The Department of Transportation shall erect and
11 maintain appropriate signs displaying the name of the bridge to
12 traffic in both directions on the bridge.

13 Section 58. Corporal Brady Clemens Paul Memorial Highway.

14 (a) Findings.--The General Assembly finds and declares as
15 follows:

16 (1) Corporal Brady Clemens Paul was born November 7,
17 1904, in Hickory, Pennsylvania.

18 (2) On January 7, 1926, when Corporal Paul was 22 years
19 of age, he enlisted with the State Highway Patrol.

20 (3) On December 27, 1929, at 11:50 a.m., Corporal Paul
21 and Patrolman Ernest Moore set up a roadblock on Butler
22 Highway, three miles east of New Castle, to stop a motor
23 vehicle.

24 (4) When Corporal Paul asked the driver to step out of
25 the vehicle, a passenger came around the side of the vehicle
26 and opened fire on the officers.

27 (5) Corporal Paul's dying words were "Tell the boys I
28 did my duty, I did my best."

29 (6) Corporal Paul was pronounced dead on arrival at
30 Jameson Memorial Hospital in New Castle.

31 (7) Nineteen days later, the escapees were apprehended
32 after a shoot-out with a sheriff's posse in Arizona and were
33 extradited to this Commonwealth where they were tried,
34 sentenced and executed for murder.

35 (b) Designation.--The section of Pennsylvania Route 50 in
36 Mount Pleasant Township, Washington County, identified as
37 Segment 210-220, is designated the Corporal Brady Clemens Paul
38 Memorial Highway.

39 (c) Signs.--The Department of Transportation shall erect and
40 maintain appropriate signs displaying the name of the highway to
41 traffic in both directions on the highway.

42 Section 59. Repeals.

43 Repeals are as follows:

44 (1) The General Assembly declares that the repeal under
45 paragraph (2) is necessary to effectuate the designation
46 under section 56 of this act.

47 (2) The act of November 17, 2021 (P.L.434, No.86), is
48 repealed.

49 (3) The General Assembly declares that the repeal under
50 paragraph (4) is necessary to effectuate the designation
51 under section 57 of this act.

1 (4) The act of February 3, 2022 (P.L.21, No.5), is
2 repealed.

3 (5) The General Assembly declares that the repeal under
4 paragraph (6) is necessary to effectuate the designation
5 under section 58 of this act.

6 (6) Section 3 of the act of July 1, 2020 (P.L.536,
7 No.45), is repealed.
