- 2 SHALL PROVIDE INFORMATION TO THE PARENT OR GUARDIAN ON HOW TO
- 3 SEND THE TICK TO THE TICK RESEARCH LAB OF PENNSYLVANIA; OR
- 4 (II) BE SENT DIRECTLY BY THE SCHOOL DISTRICT TO THE TICK
- 5 RESEARCH LAB OF PENNSYLVANIA FOR TESTING. UPON RECEIVING THE
- 6 RESULTS, THE SCHOOL DISTRICT SHALL INFORM THE CHILD'S PARENT OR
- 7 GUARDIAN OF THE RESULTS.
- 8 (2) AFTER A TICK IS removed from a student, the school
- 9 district shall notify in writing the parent or quardian of the
- 10 student. The notice shall state that:
- 11 (I) A tick was removed from your child today. Ticks can <--
- 12 transmit disease and make people sick. A common illness caused
- 13 <u>by ticks in Pennsylvania is Lyme disease.</u>
- 14 (II) Not all tick bites lead to Lyme disease.
- 15 (III) The parent or guardian should record the date on <--

- 16 which the tick was removed.
- 17 (IV) It is recommended that the parent or quardian seek <--
- 18 medical treatment from the child's doctor promptly if they
- 19 notice any early signs or symptoms of illness within three (3)
- 20 to thirty (30) days of the date of removal. Some people with
- 21 Lyme disease will get a bulls-eye rash. Others may have an
- 22 atypical rash. Not everyone who has Lyme disease gets a rash.
- 23 Other symptoms which may occur during the early state of Lyme
- 24 disease include: chills, fever, headache, tiredness, stiff neck,
- 25 joint pain or swelling and swollen lymph nodes. Lyme disease is
- 26 treated with antibiotics. If untreated, infection may progress
- 27 to joint, heart, brain or nerve abnormalities.
- 28 (e.2) The Secretary of Health shall publish guidelines
- 29 consistent with subsection (e.1) on the Department of Health's
- 30 publicly accessible Internet website and, in consultation with

- 1 the Secretary of Education, provide the guidelines to school
- 2 <u>districts</u>.
- 3 Section 2. This act shall take effect in 60 days.
