## AN ACT

Amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in general provisions, further 2 providing for definitions; in Commonwealth services, further 3 providing for definitions relating to intrastate mutual aid 4 and for definitions relating to Fire and Emergency Medical 5 Services Loan Program; in volunteer firefighters, further-6 providing for definitions relating to fire relief 7 association;; AND, in emergency responder mental wellness and <--8 stress management, further providing for definitions.; in-9 grants to fire companies and emergency medical services 10 companies, further providing for definitions; and, in-11 incentives for municipal volunteers of fire companies and 12 nonprofit emergency medical services agencies, further 13 providing for definitions. 14 15 The General Assembly of the Commonwealth of Pennsylvania 16 hereby enacts as follows: 17 Section 1.
